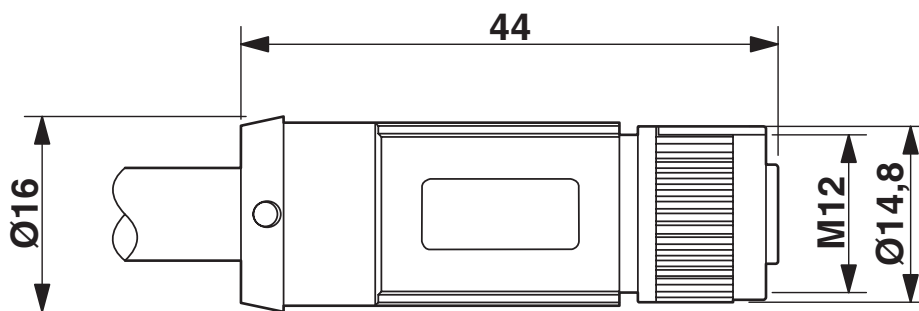

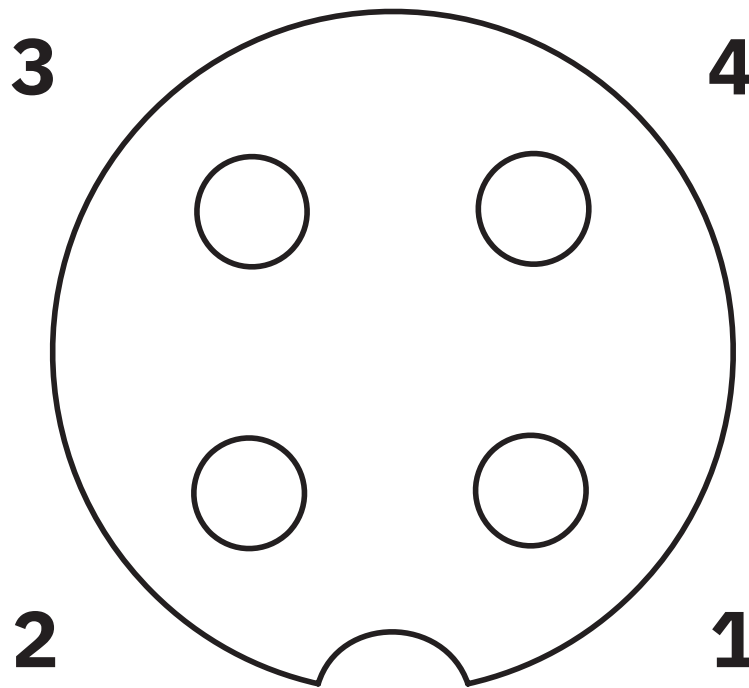
Socket M12-SPEEDCON, straight, shielded
