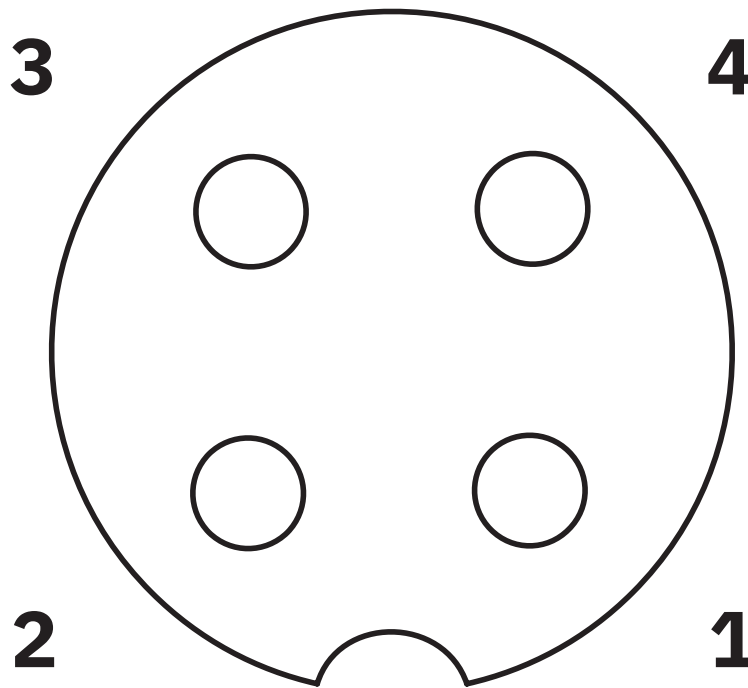
M12 x 1 male plug, angled

Schematic diagram



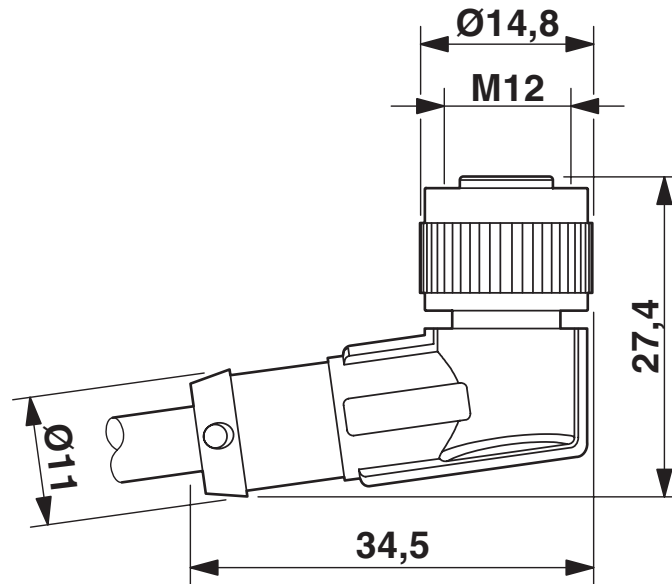
Pin assignment M12 socket, 4-pos., A-coded, view female side

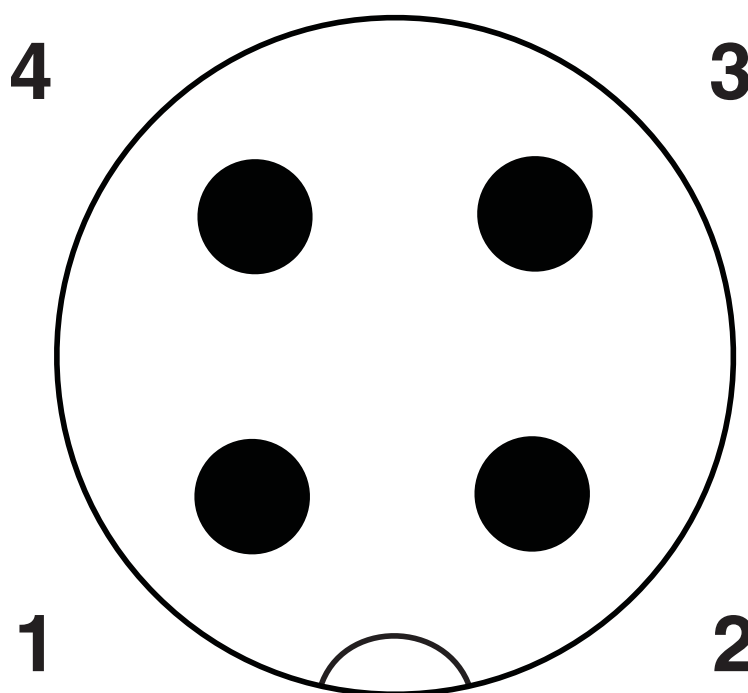
M12 x 1 socket, angled

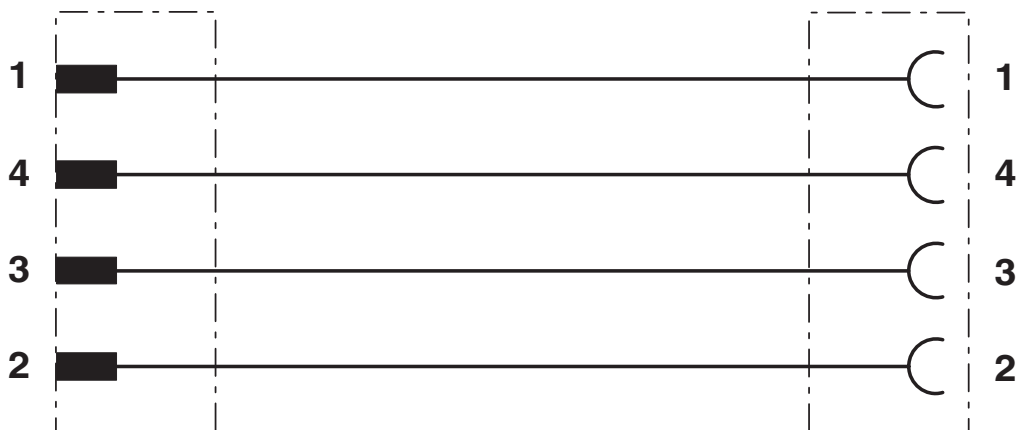
