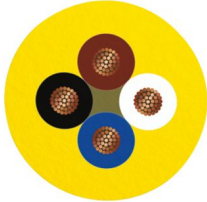

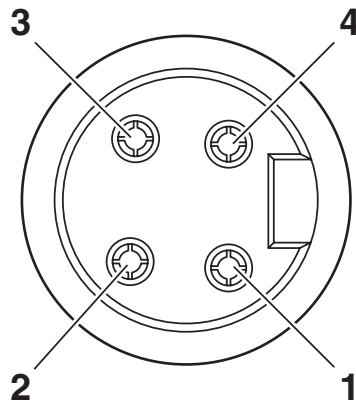

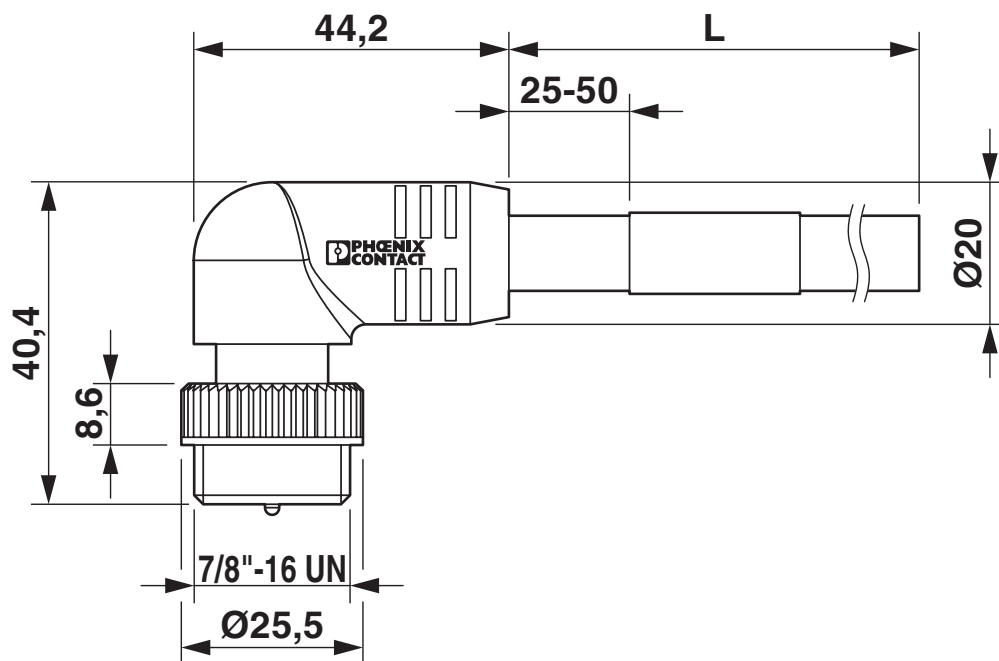

Dimensional drawing



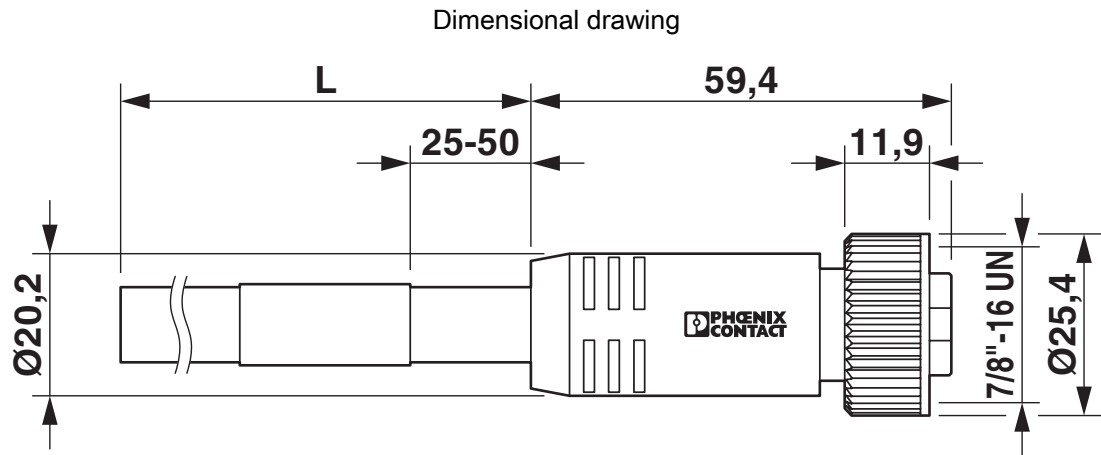
7/8"-16UNF plug, angled

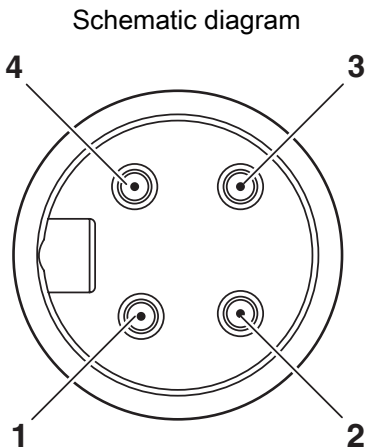

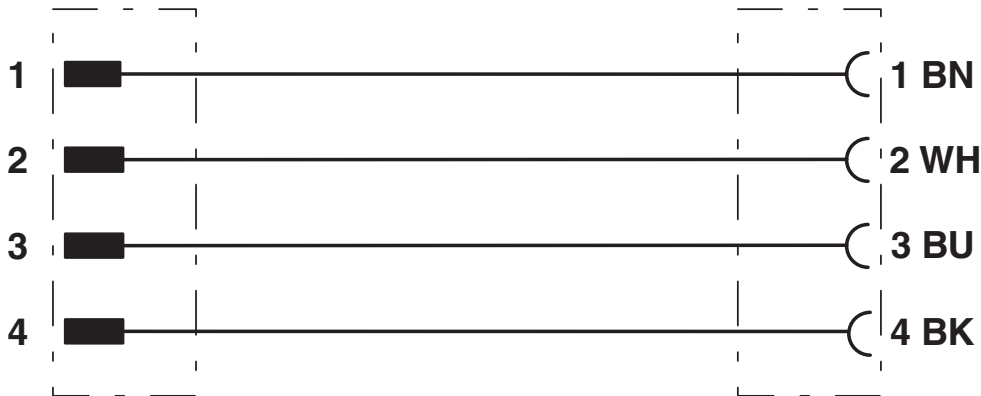


7/8"-16UNF socket, straight
