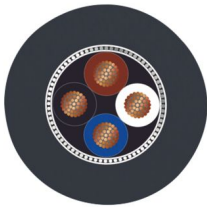

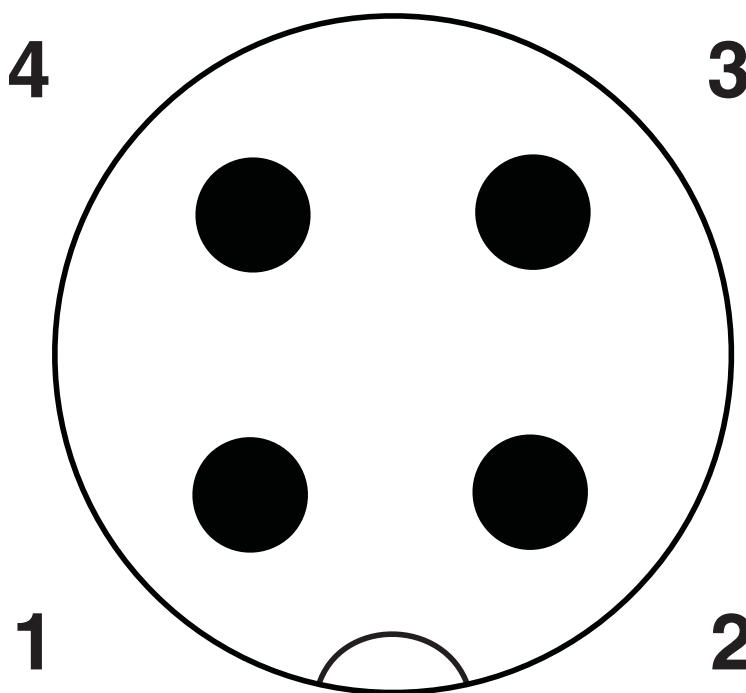

Pin assignment M12 plug, 4-pos., A-coded, view plug side

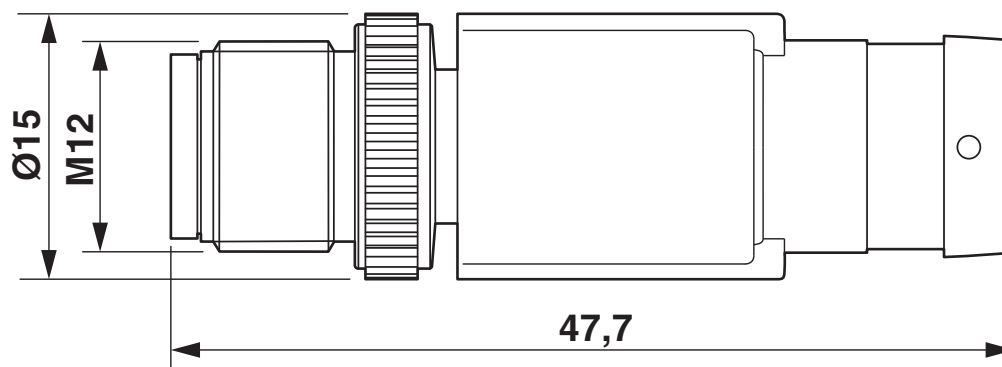

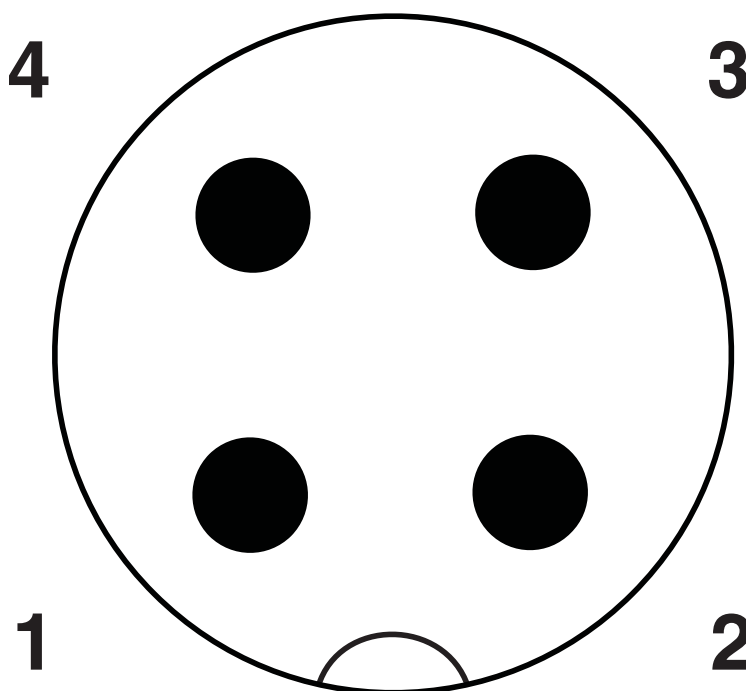

Pin assignment M12 socket, 4-pos., A-coded, view female side

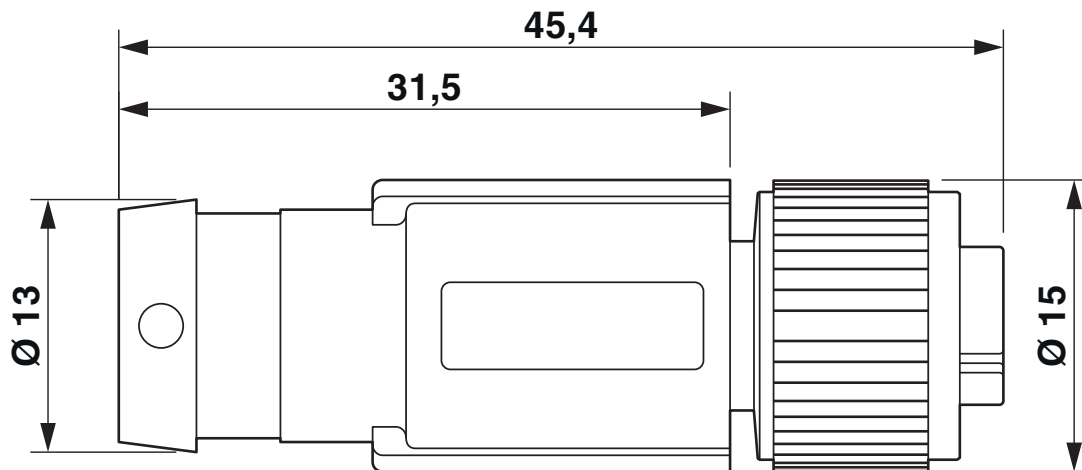
