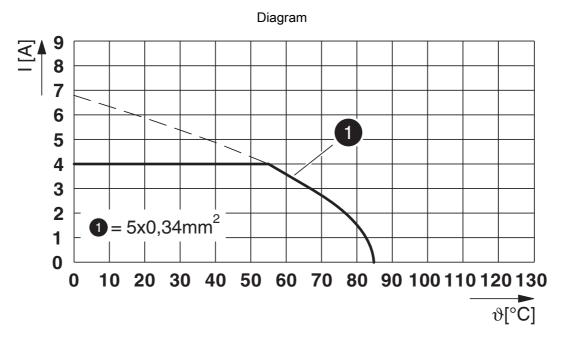

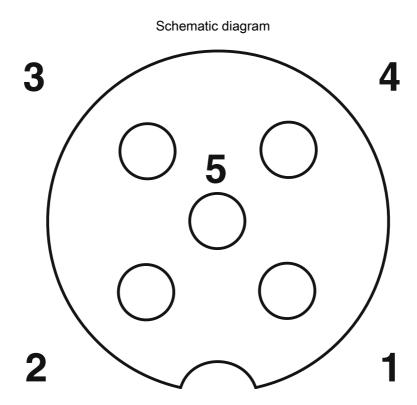
Circuit diagram
