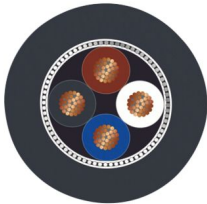

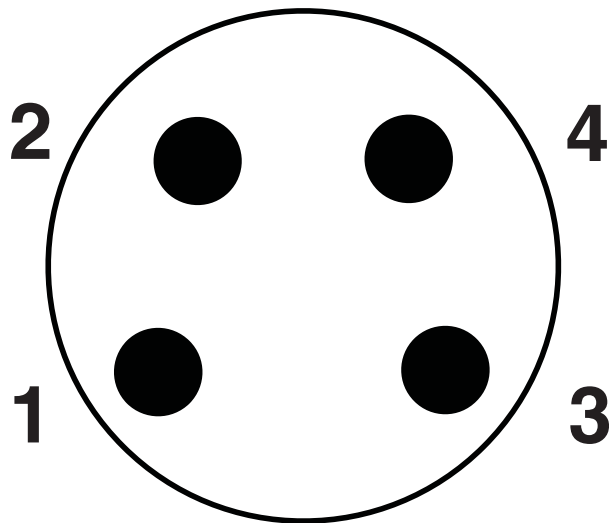

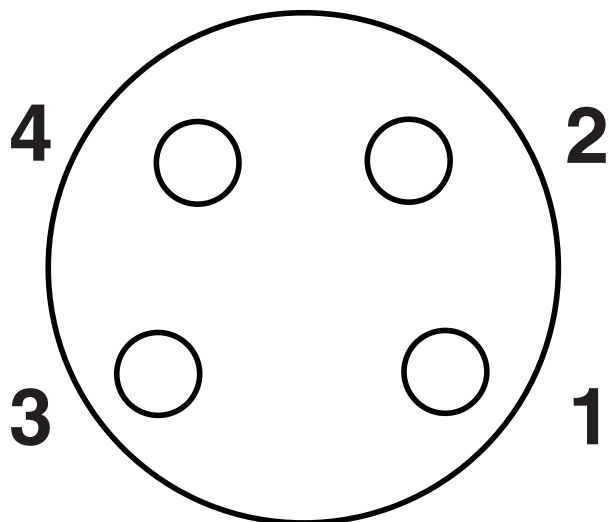

Schematic diagram



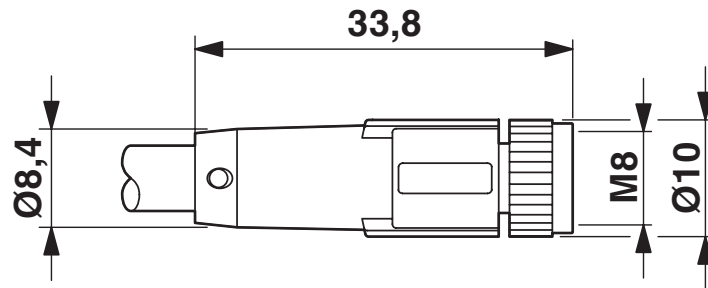
Pin assignment M8 socket, 4-pos., view female side

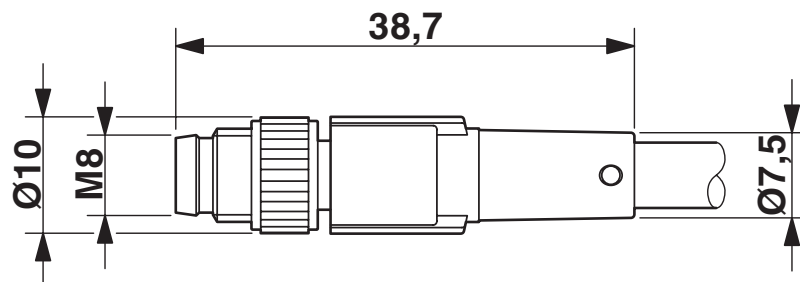

M8 x 1 male plug, straight version

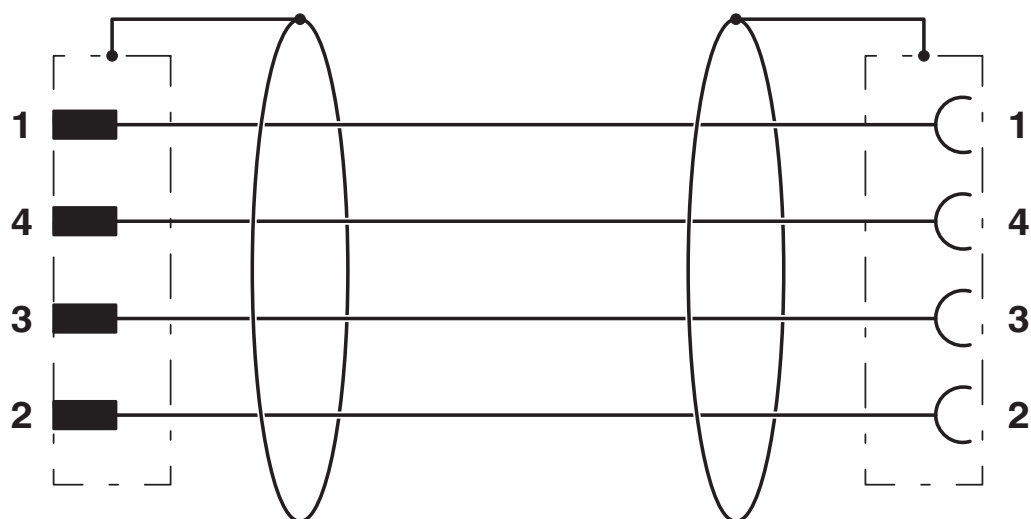
