

Schematic diagram



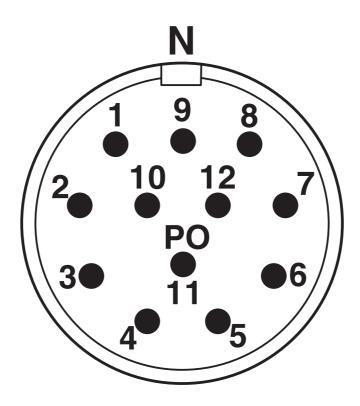
