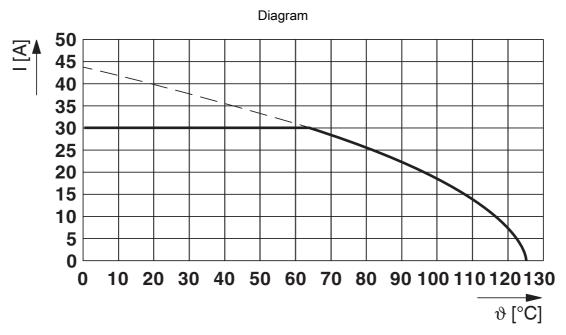

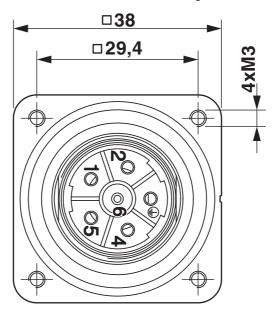


Flange dimensions (Figure shows the 6-pos. version)




Schematic diagram




Installation dimensions
