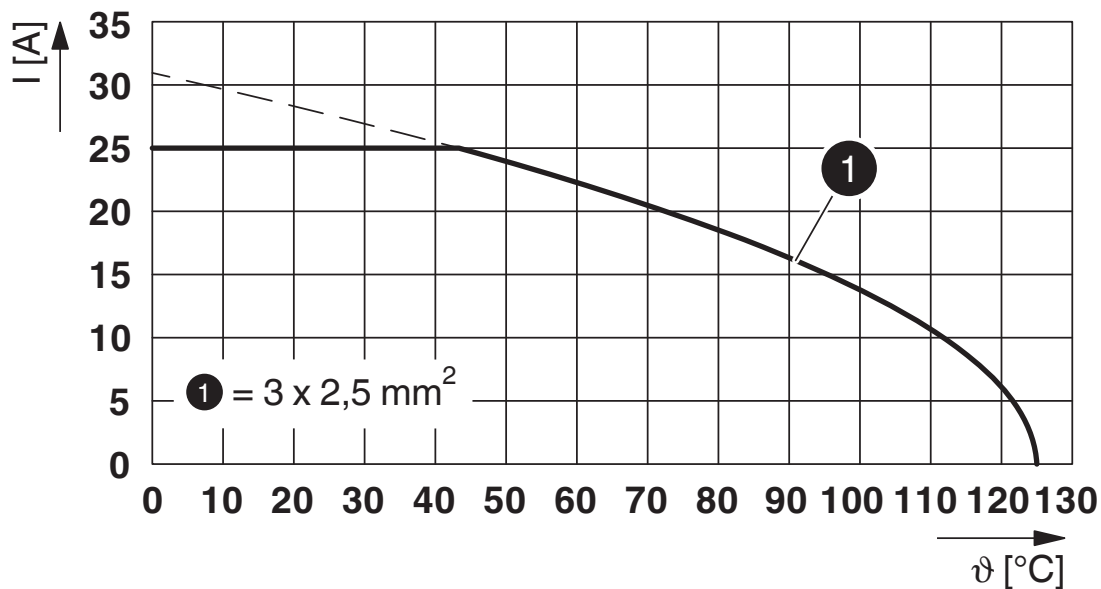

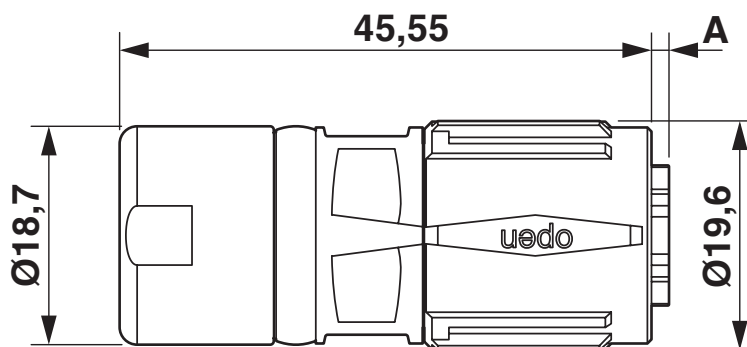

Dimensional drawing



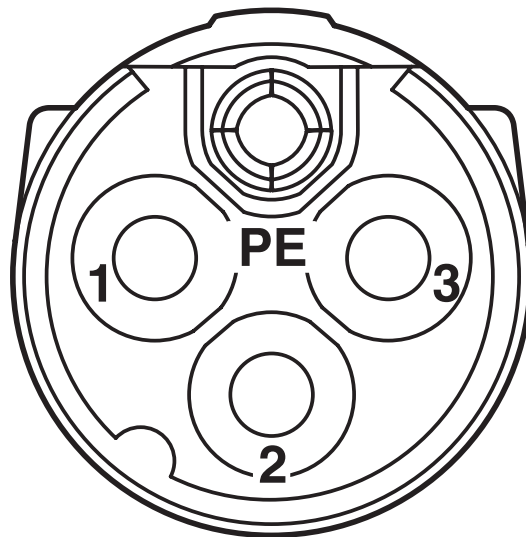
