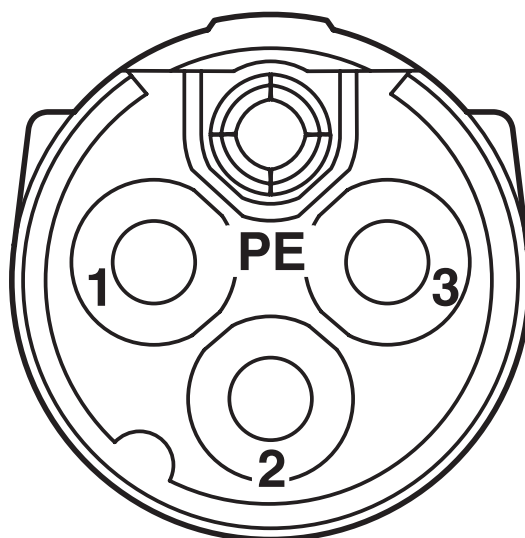

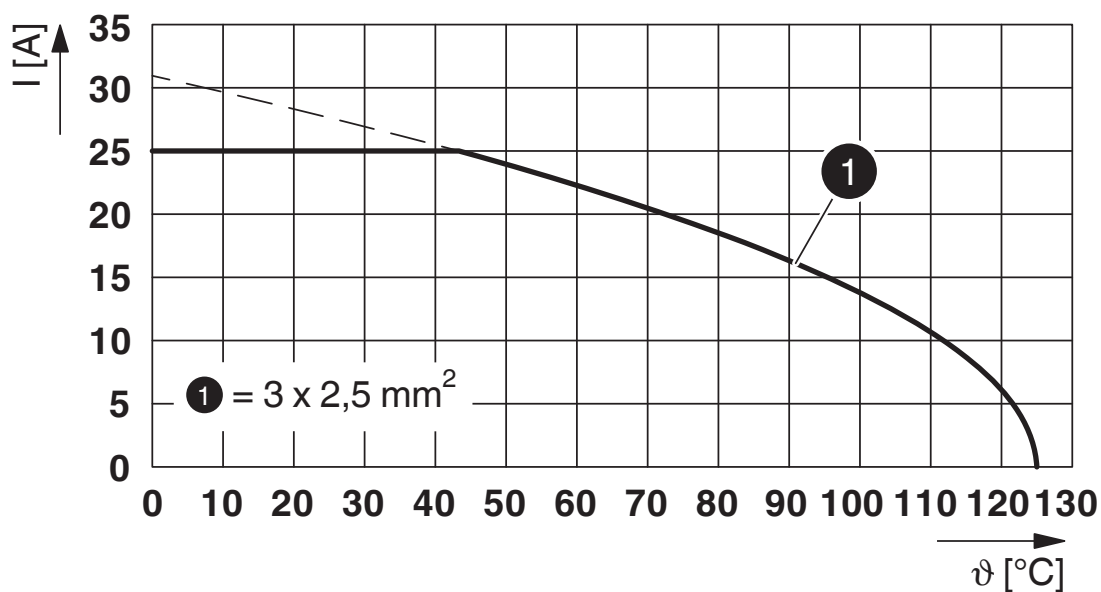

I = current strength, θ = ambient temperature, 3x 25 A

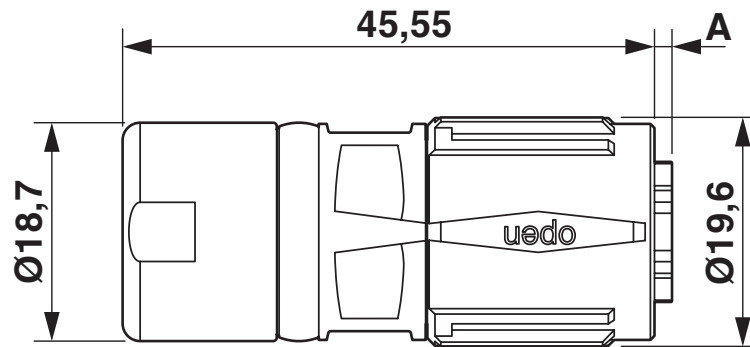
