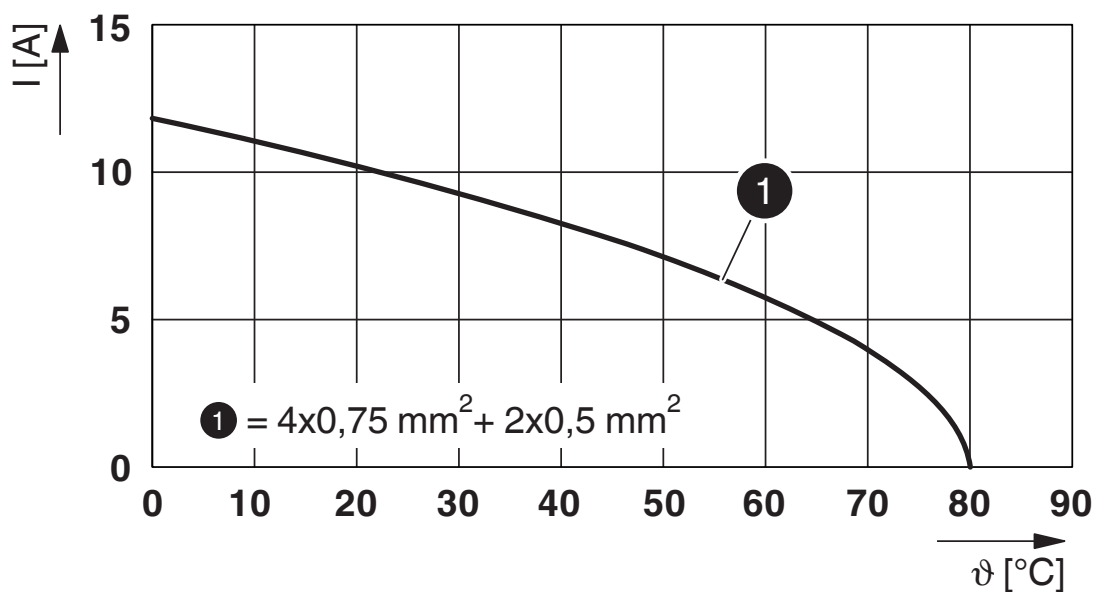

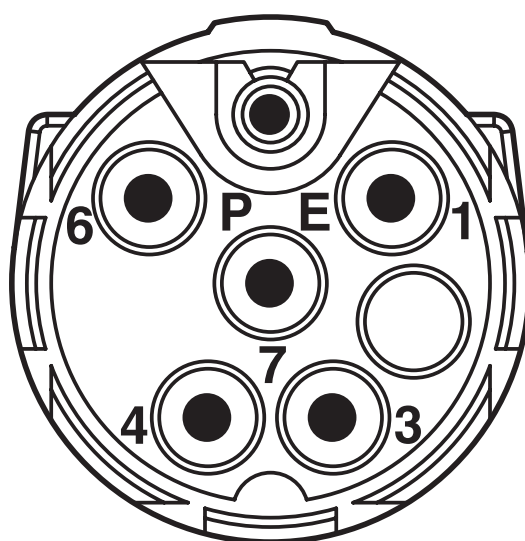

Schematic diagram



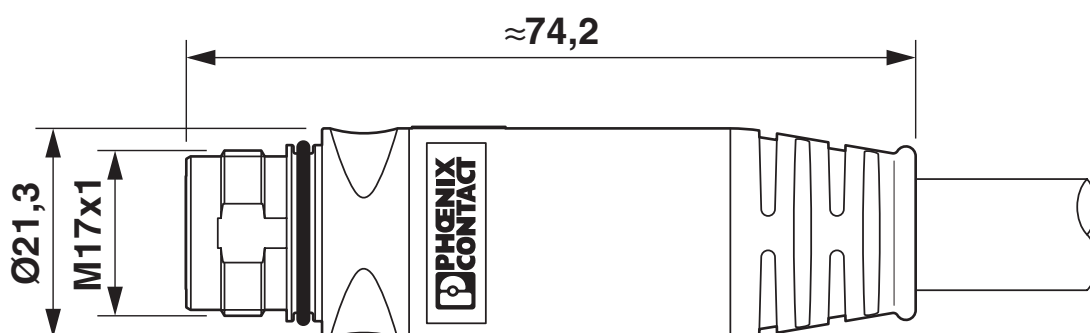
Pin assignment of pin

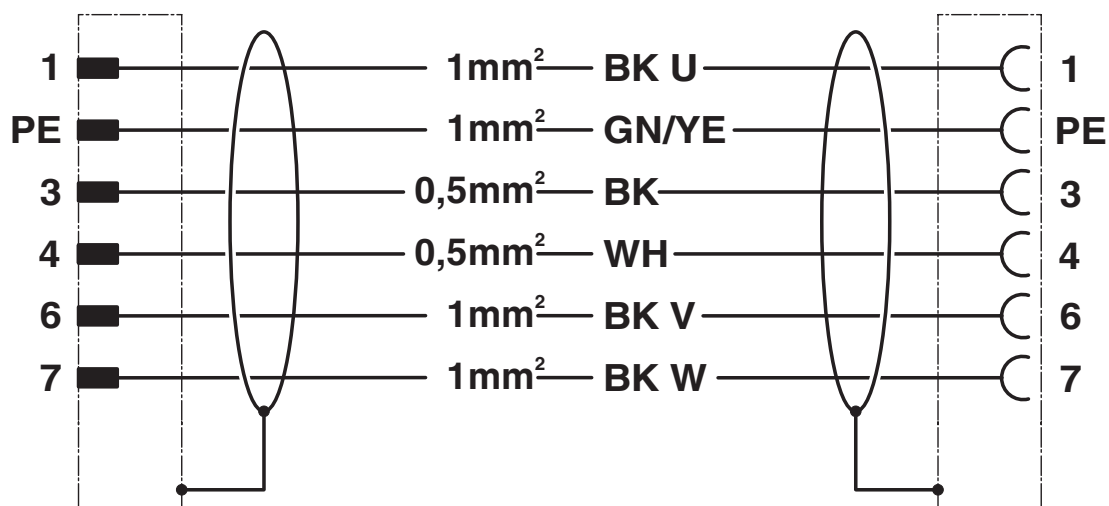

Circuit diagram



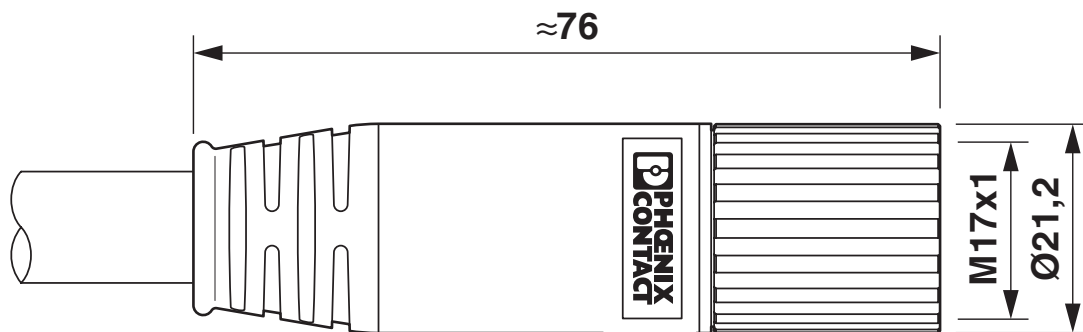

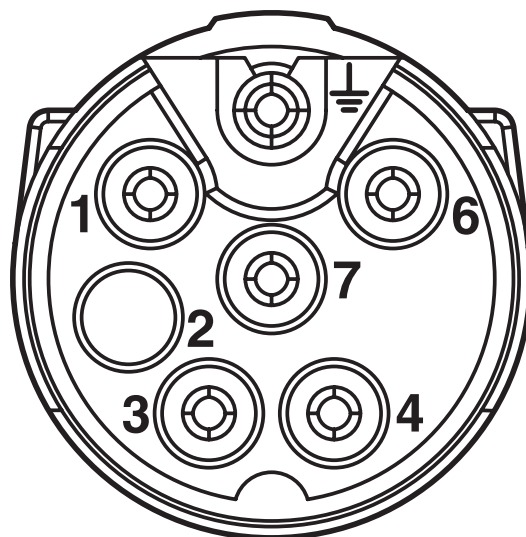
