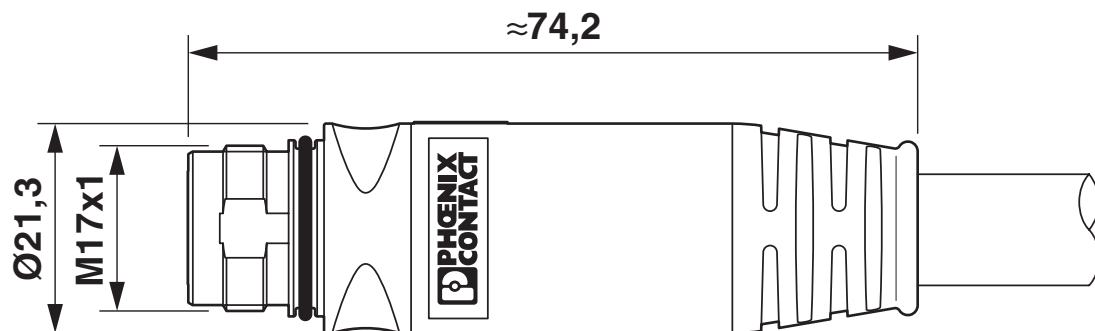

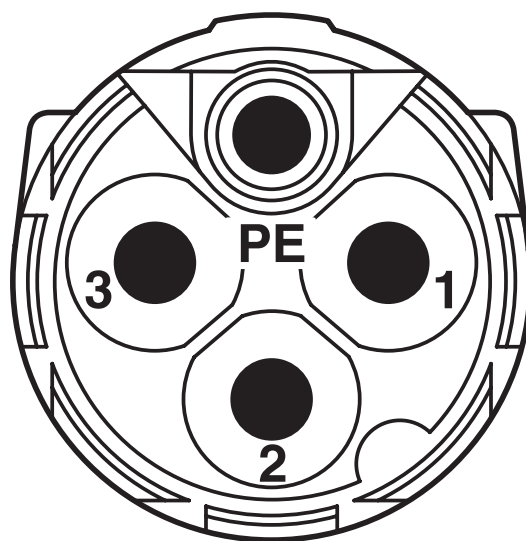

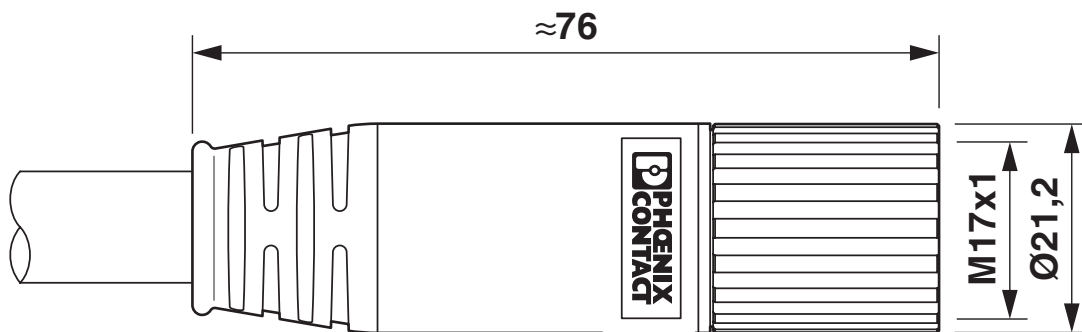

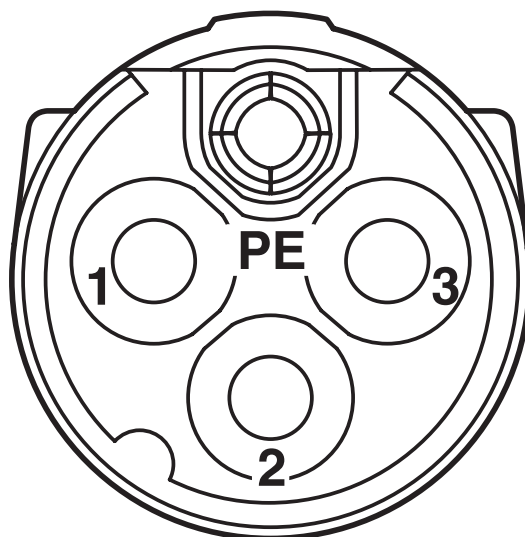
On the female side

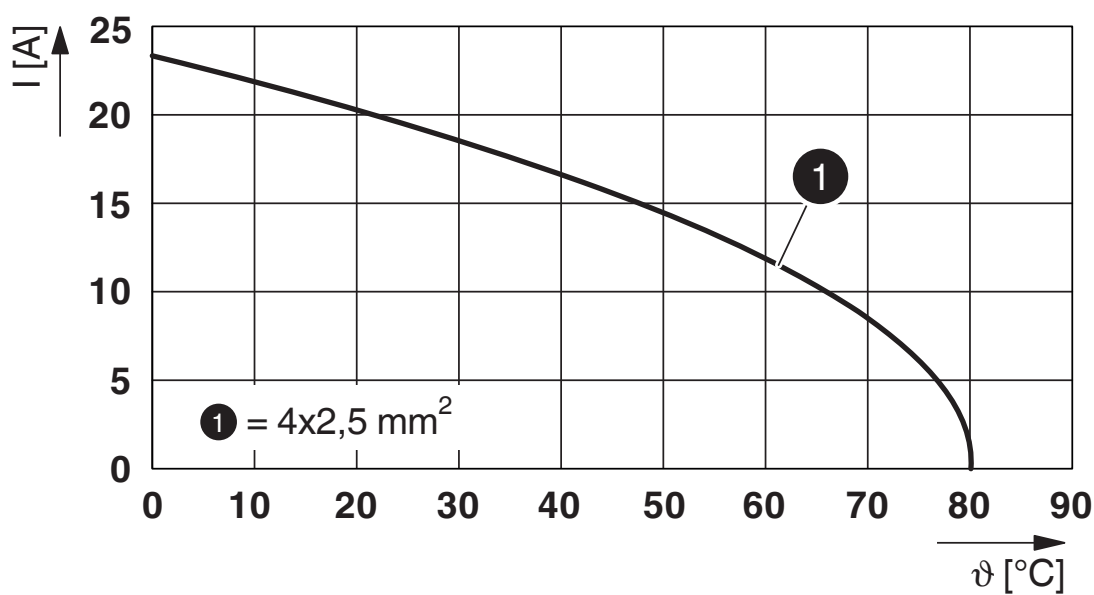
