Connector pin assignment

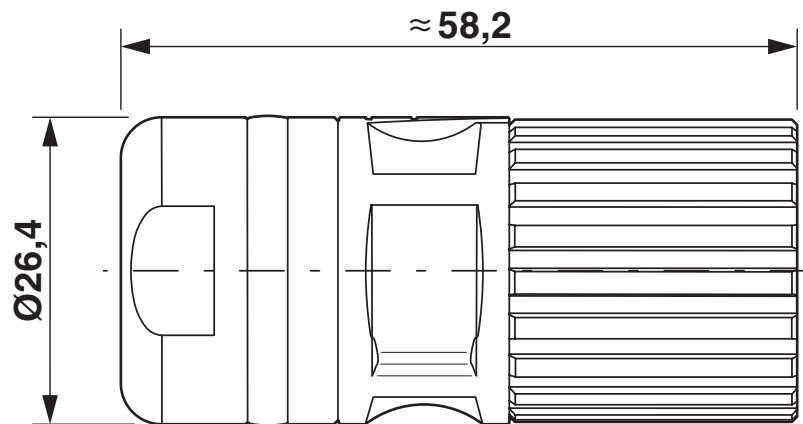
