

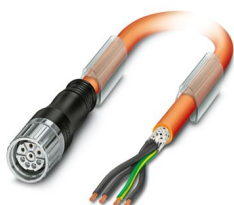

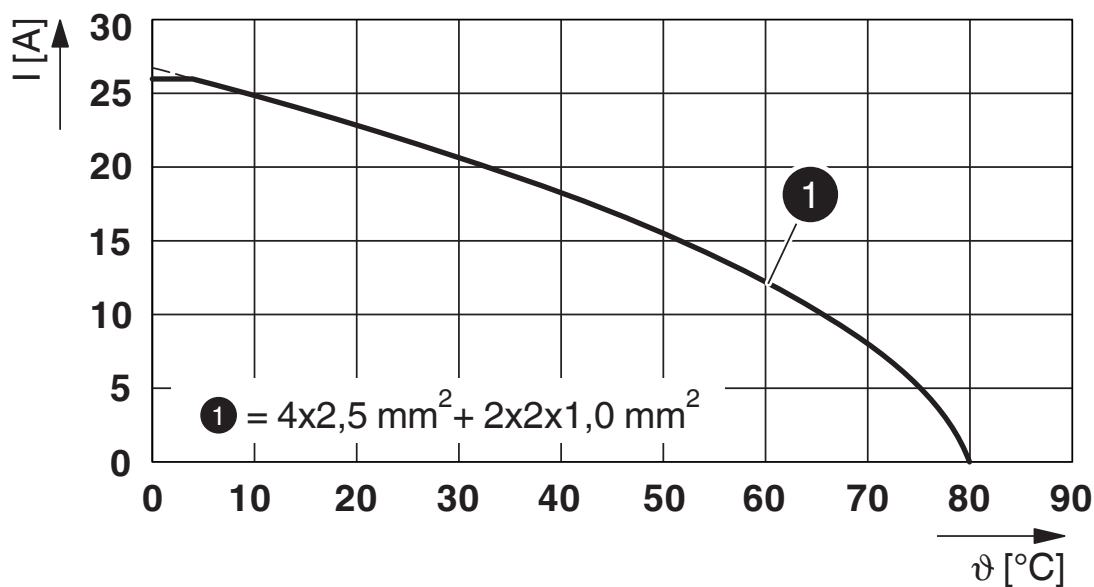

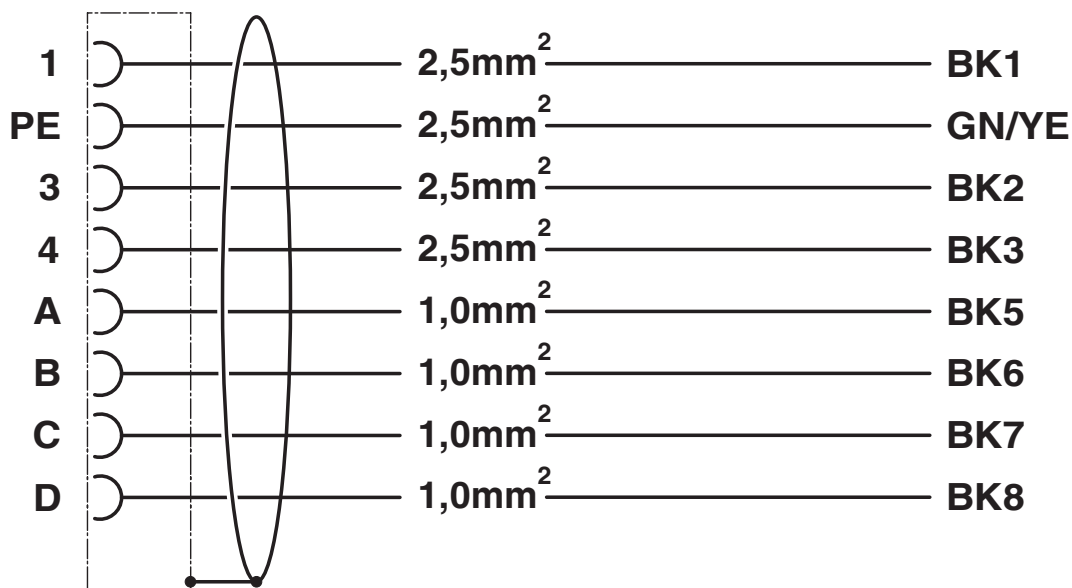

Circuit diagram

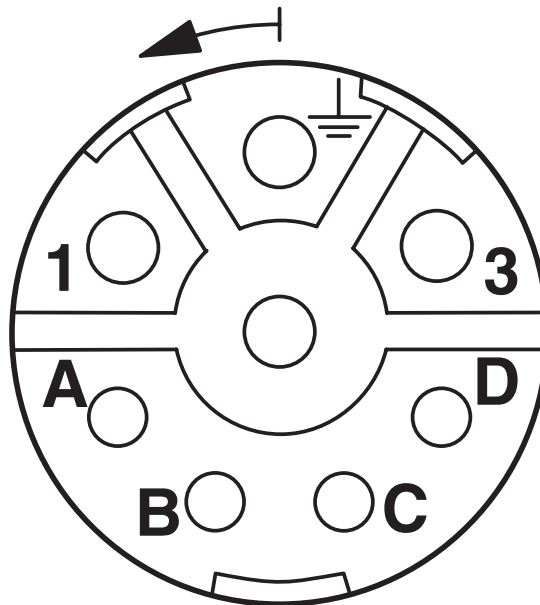

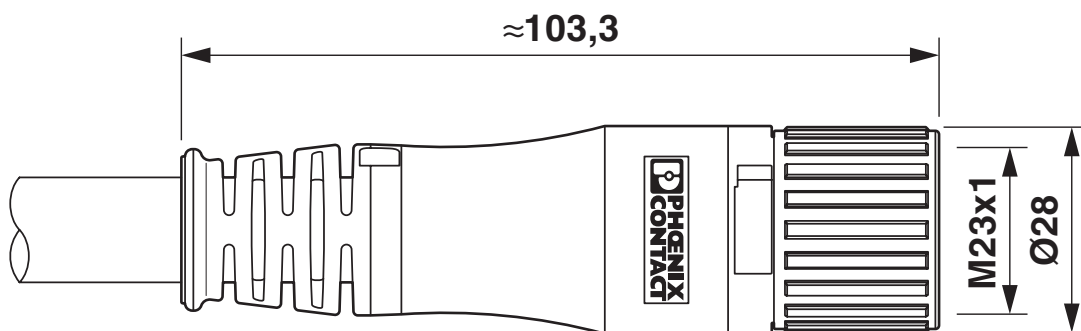
