

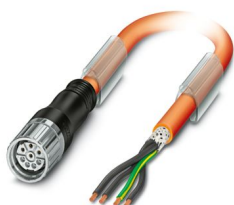

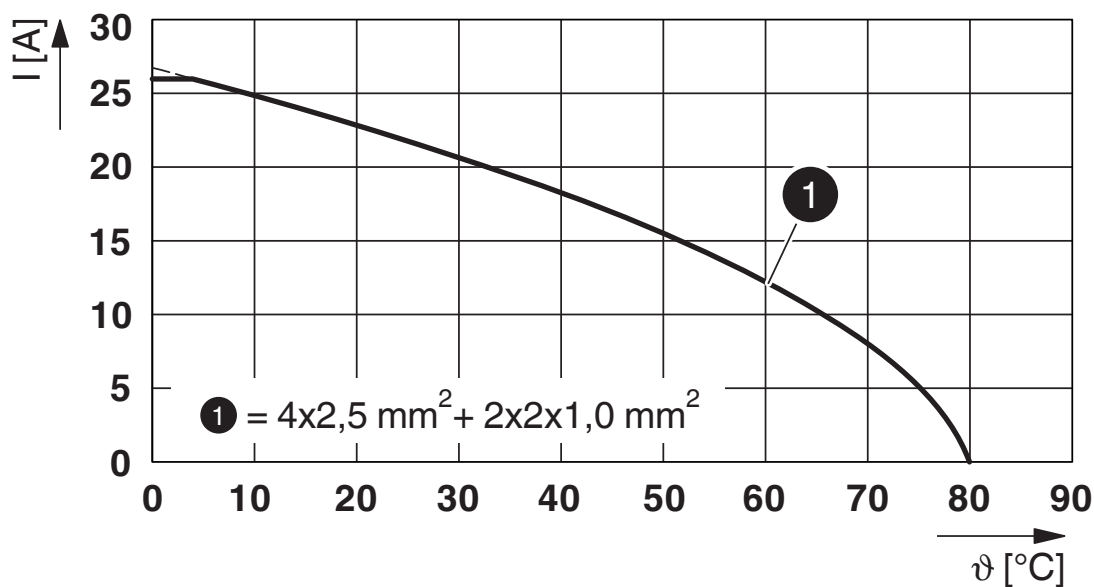

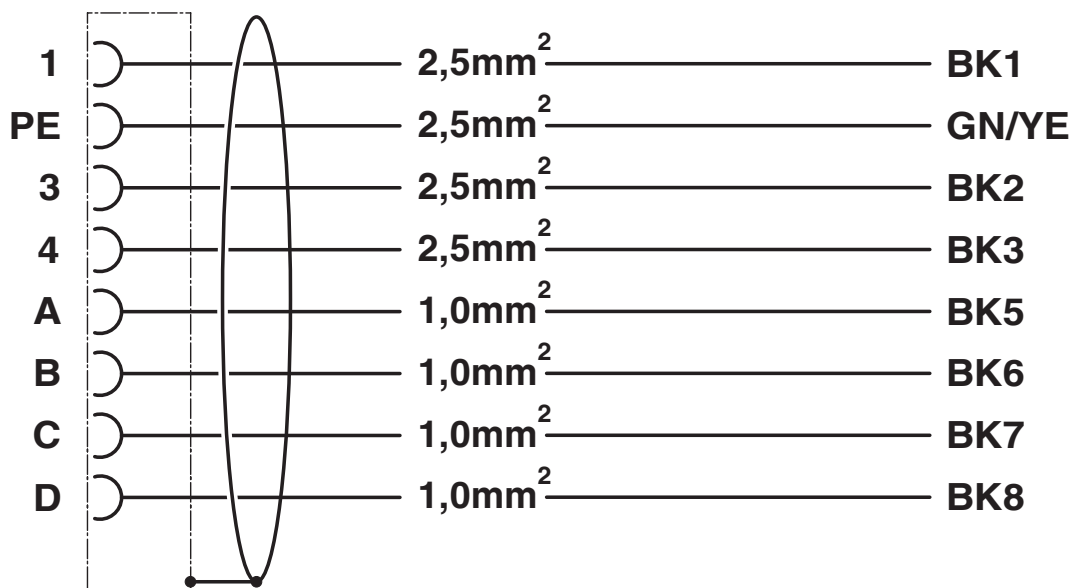

Circuit diagram

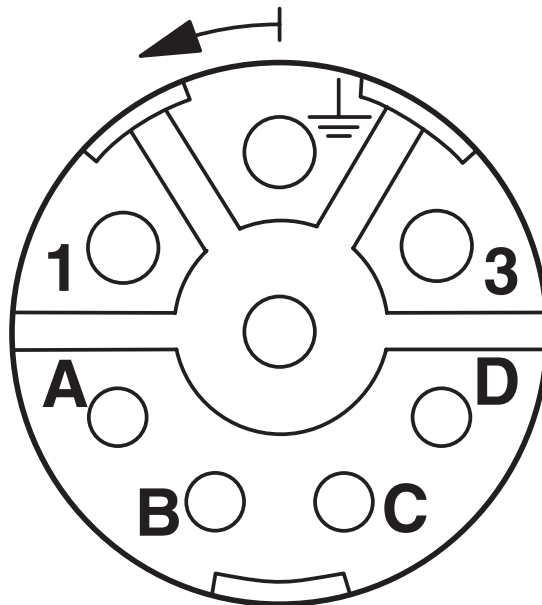

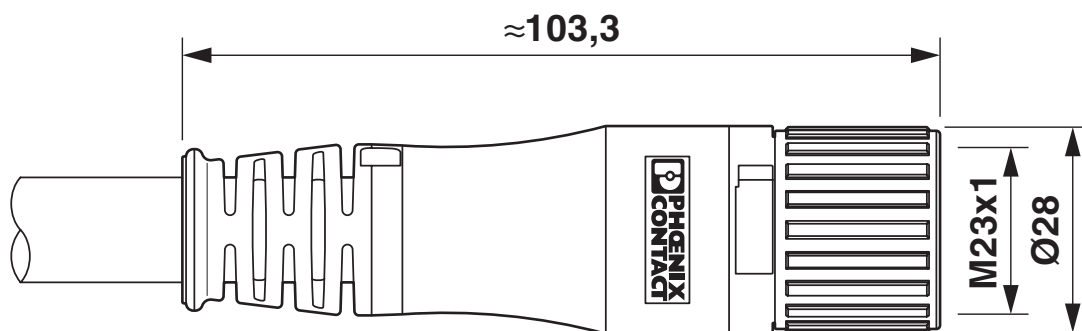
