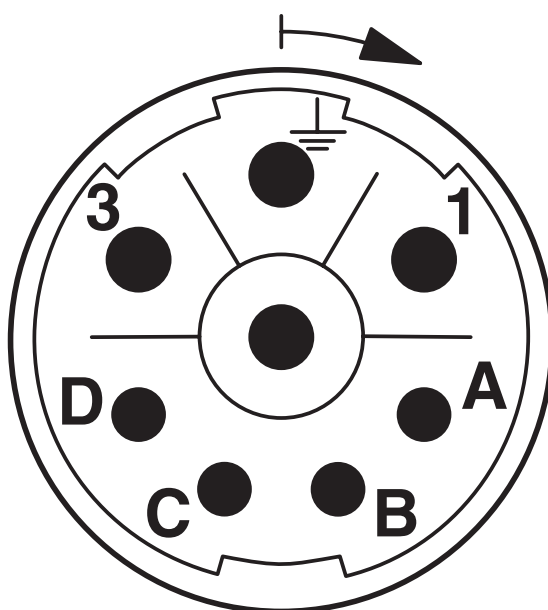

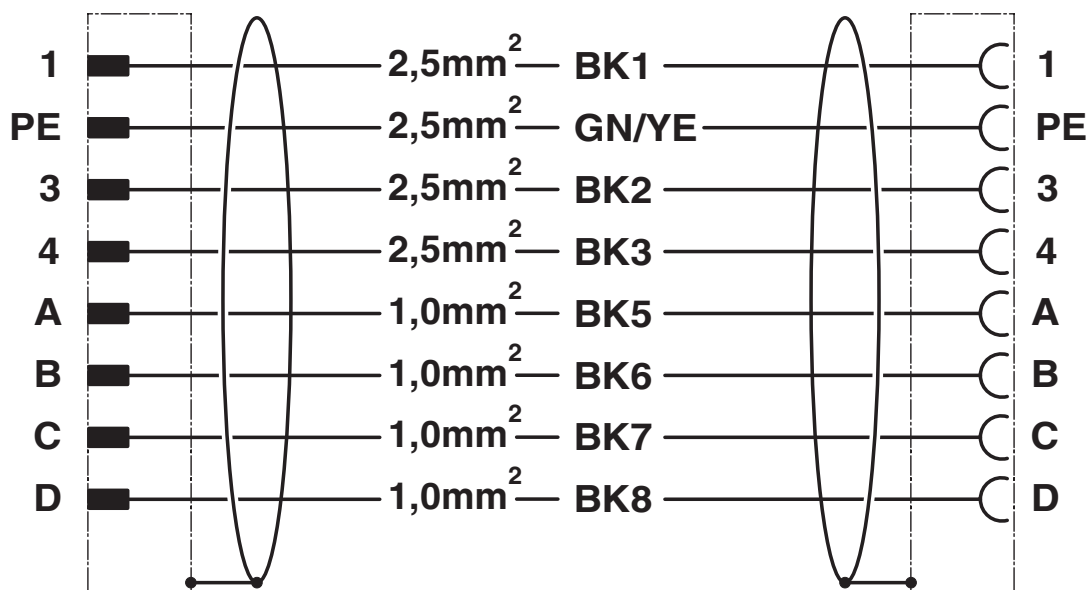

Circuit diagram

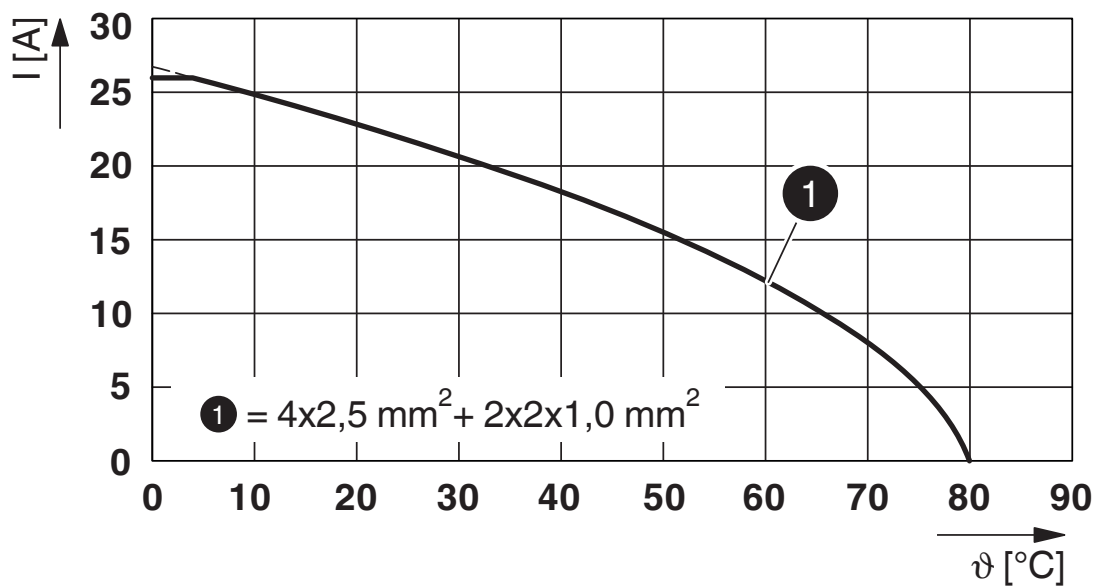

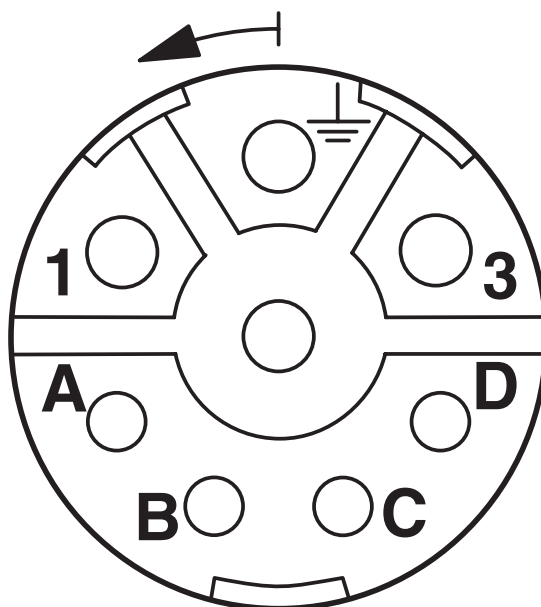

Socket pin assignment

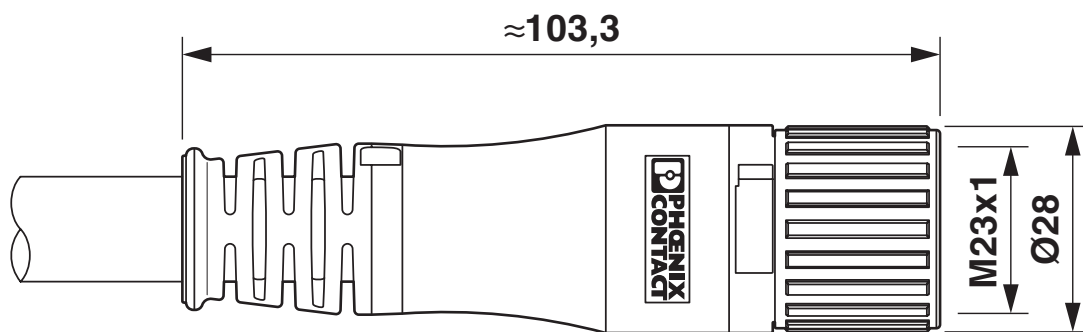

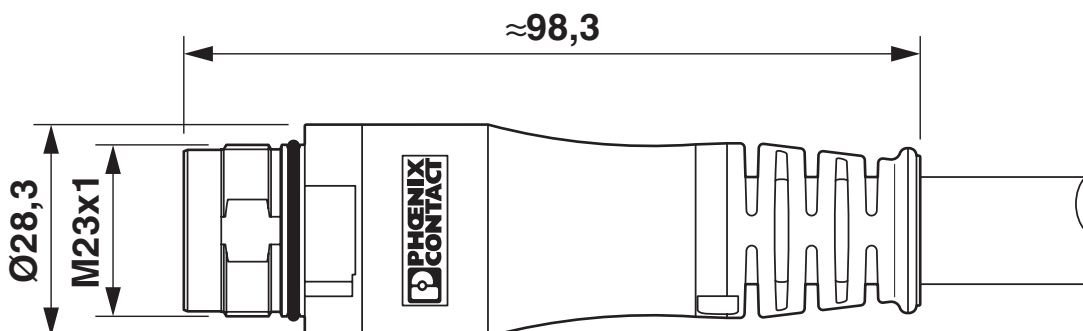
