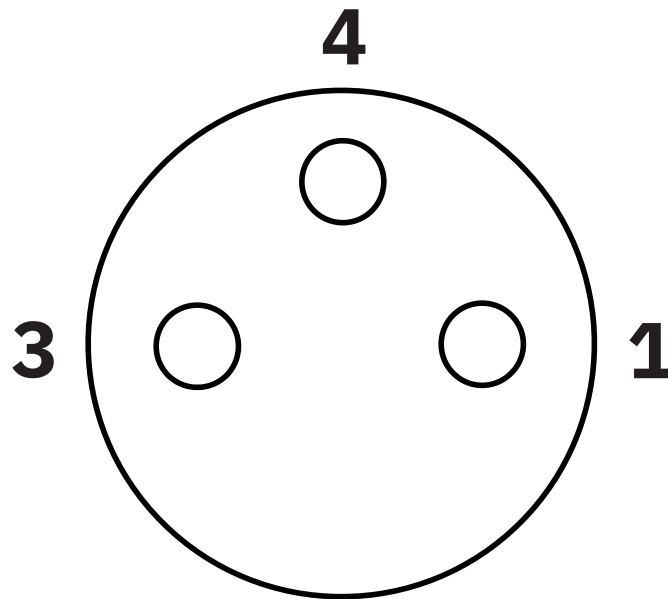

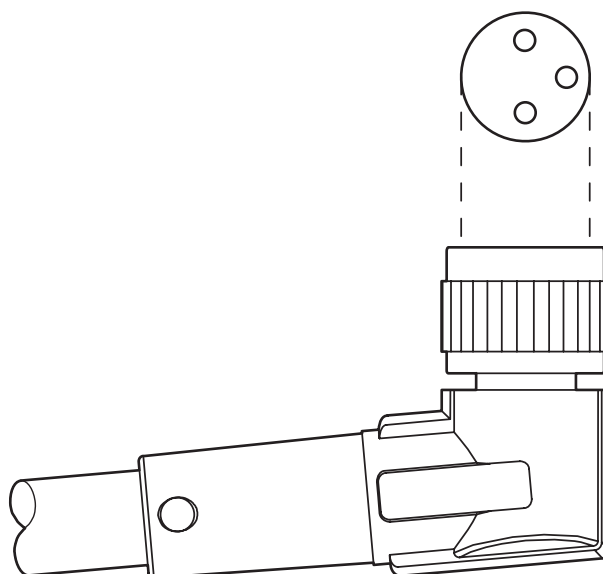

Schematic diagram



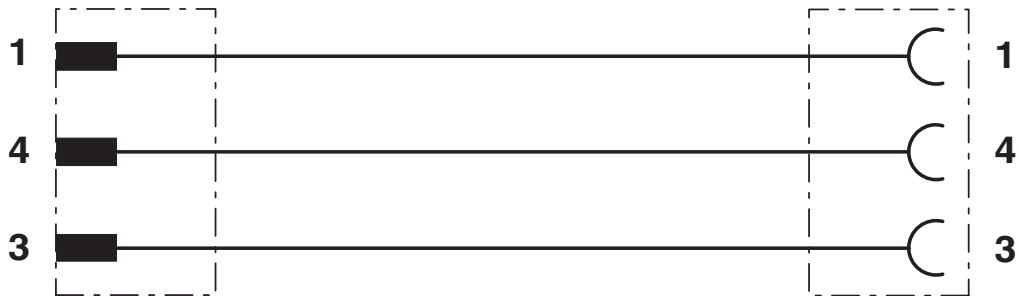
Layout of connector pin assignments

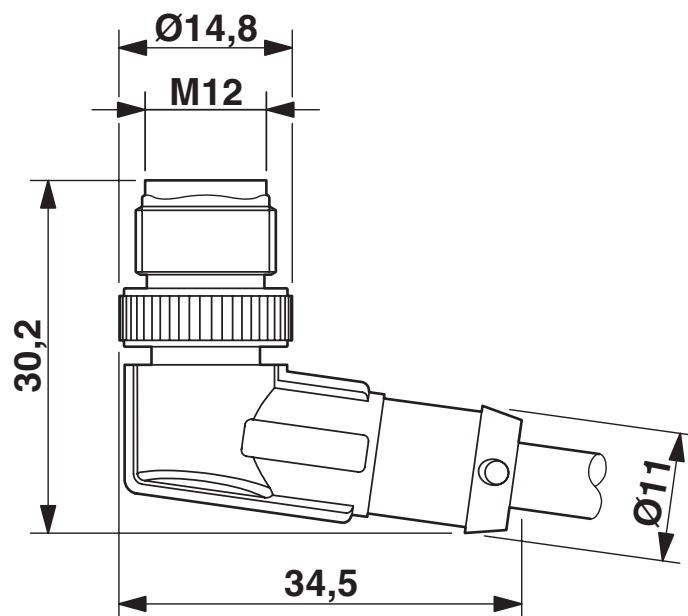

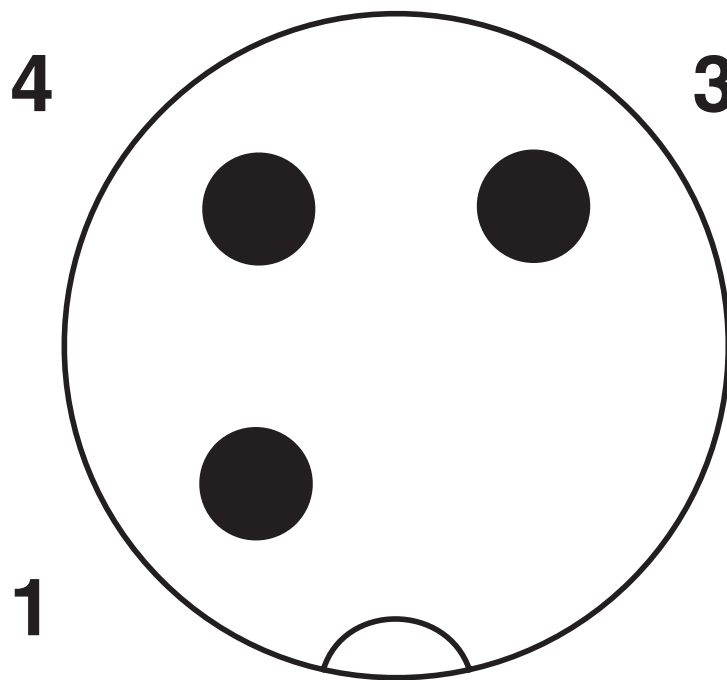
M12 x 1 male plug, angled

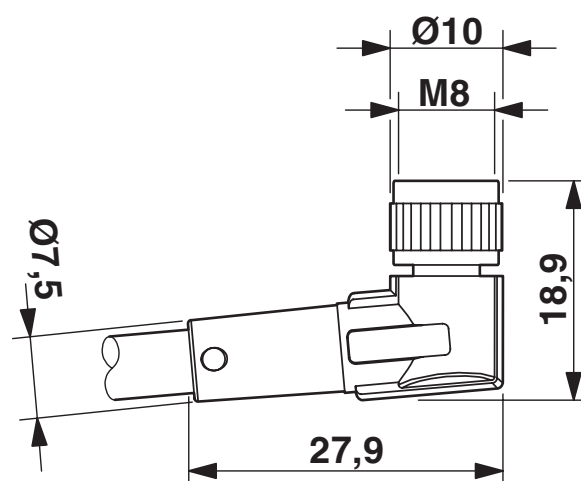
