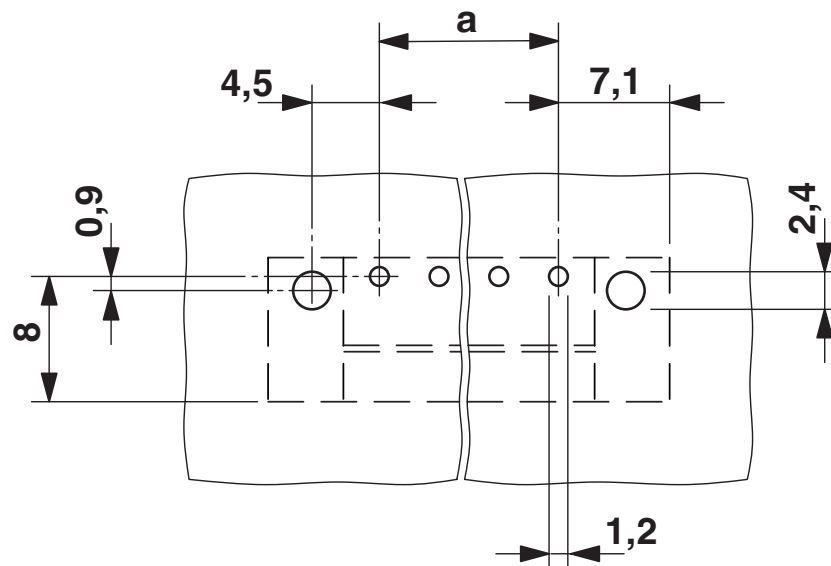

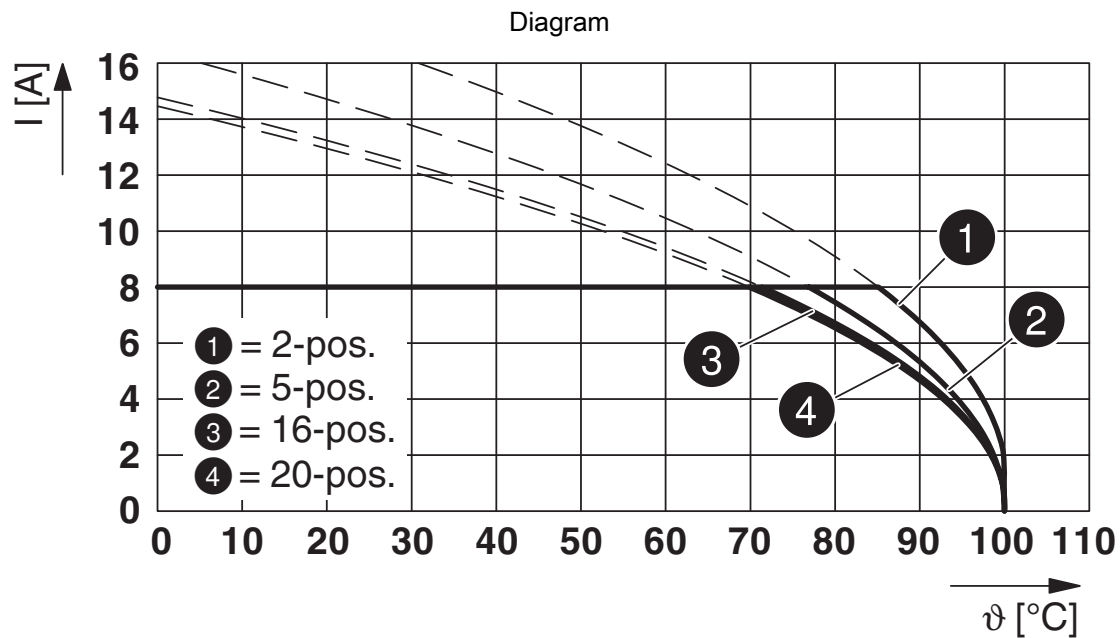
Drilling plan/solder pad geometry



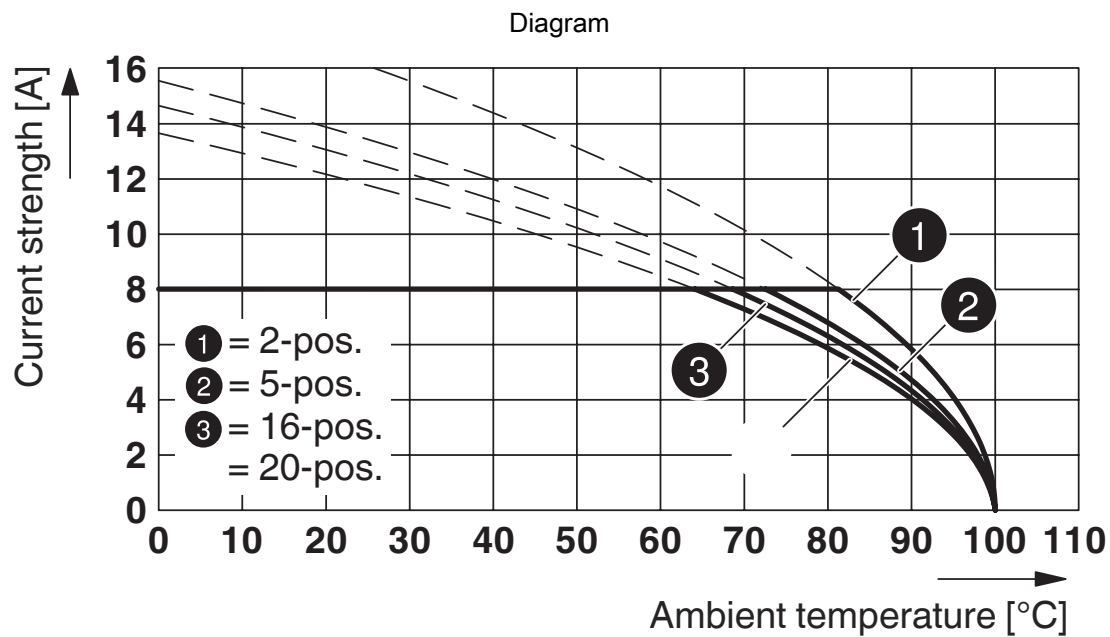

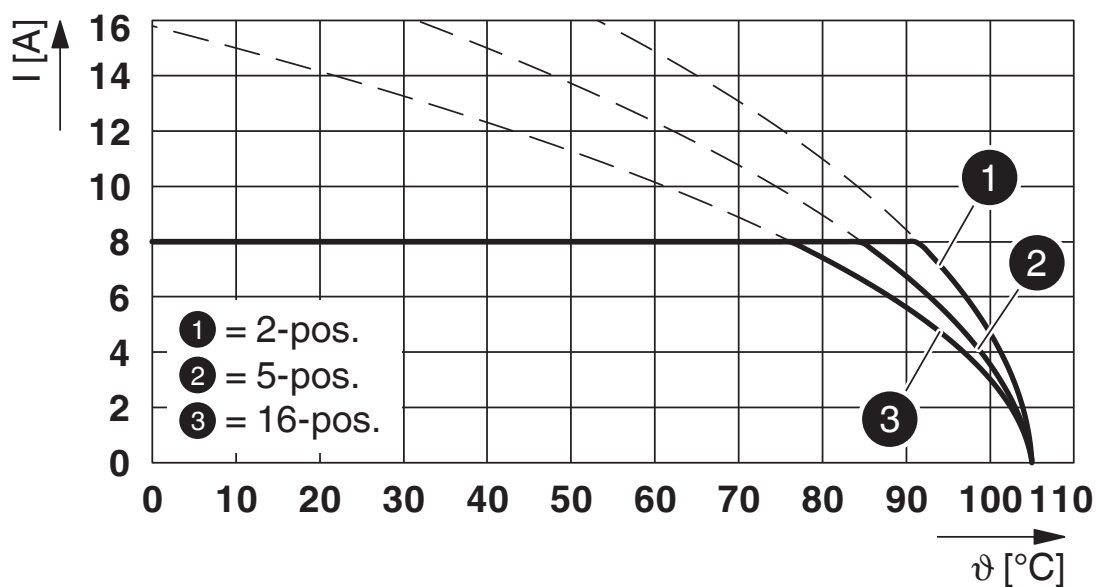

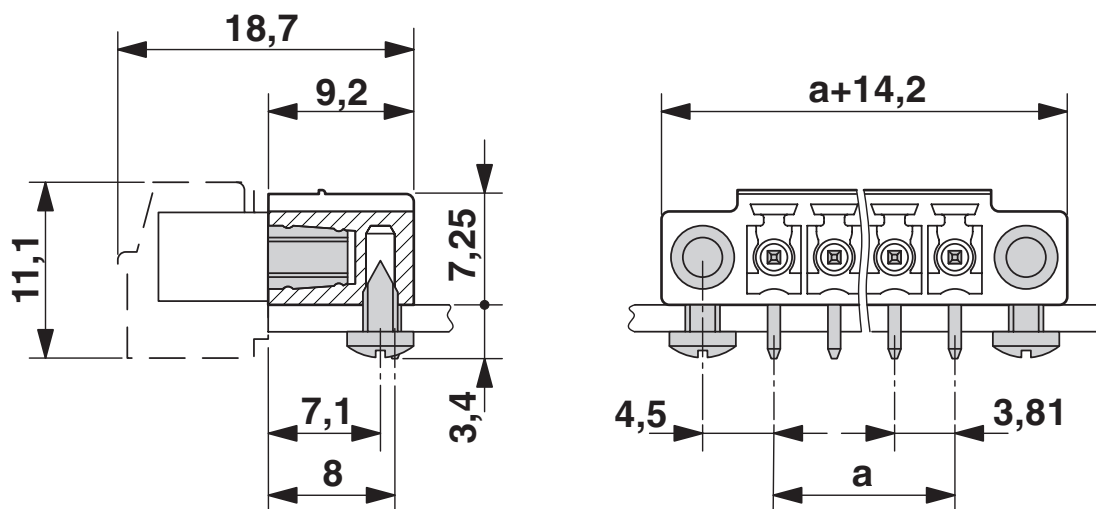

Type: LPC 1,5/...-STF-3,81 with MC 1,5/...-GF-3,81

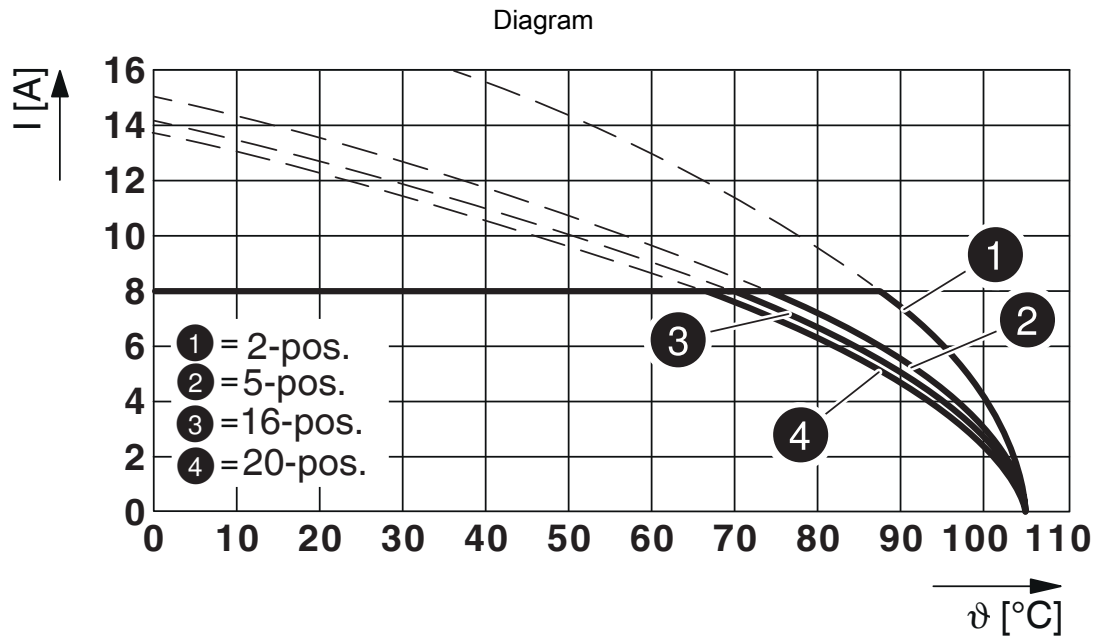

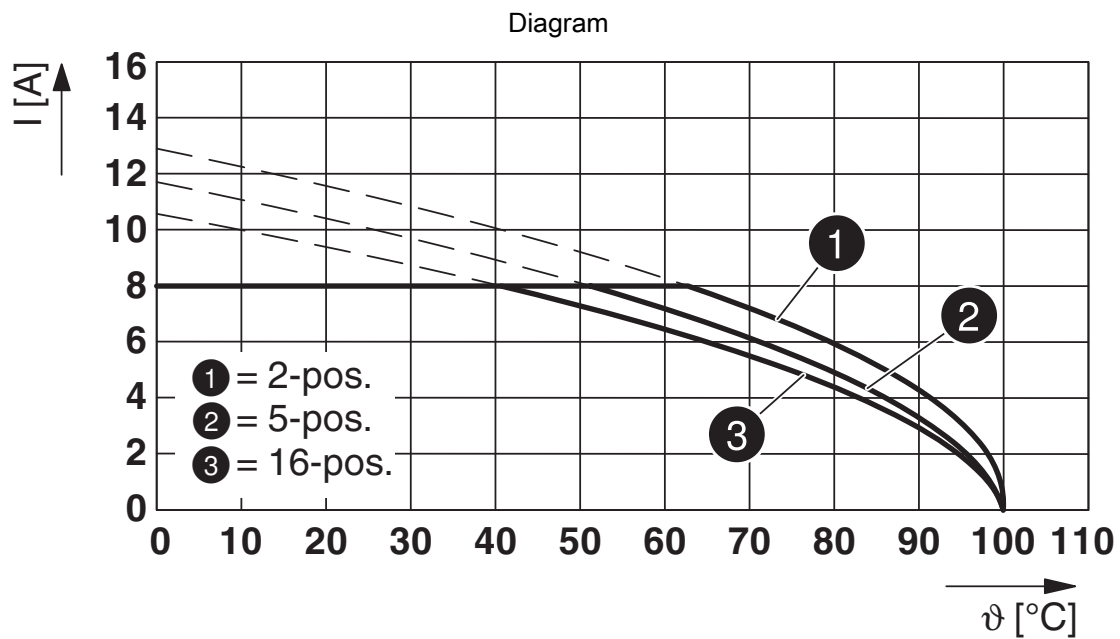
