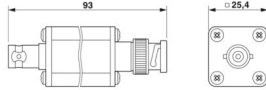

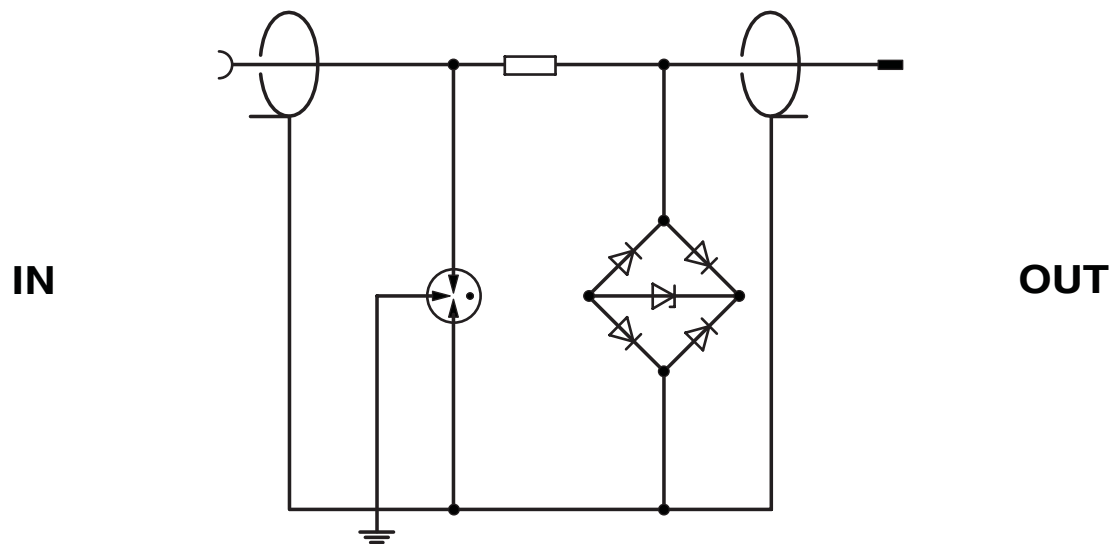

Circuit diagram



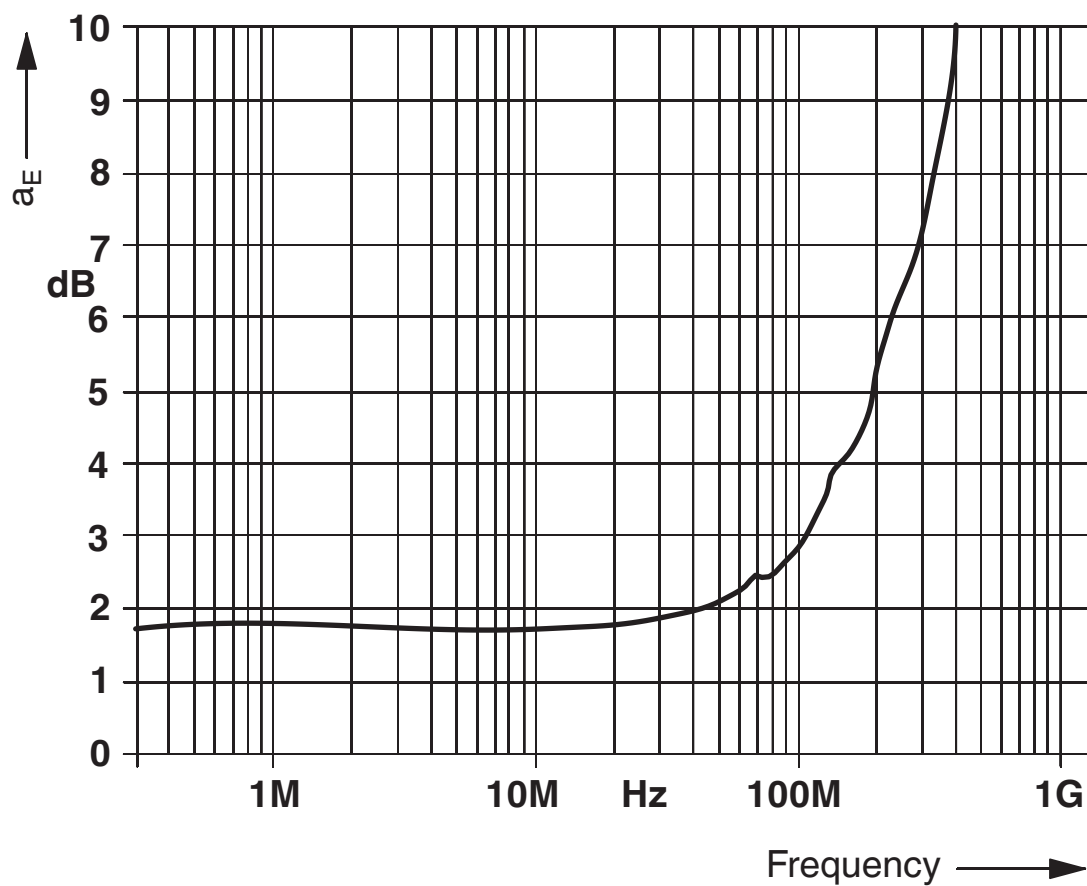

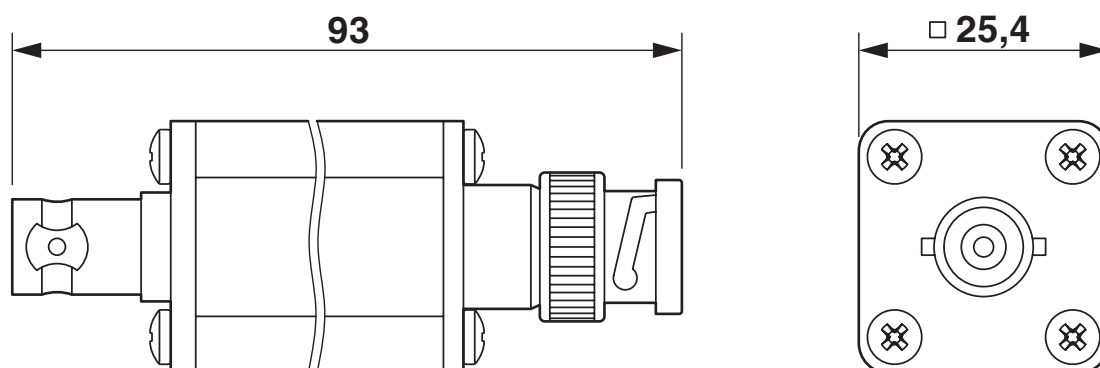
