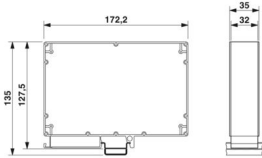

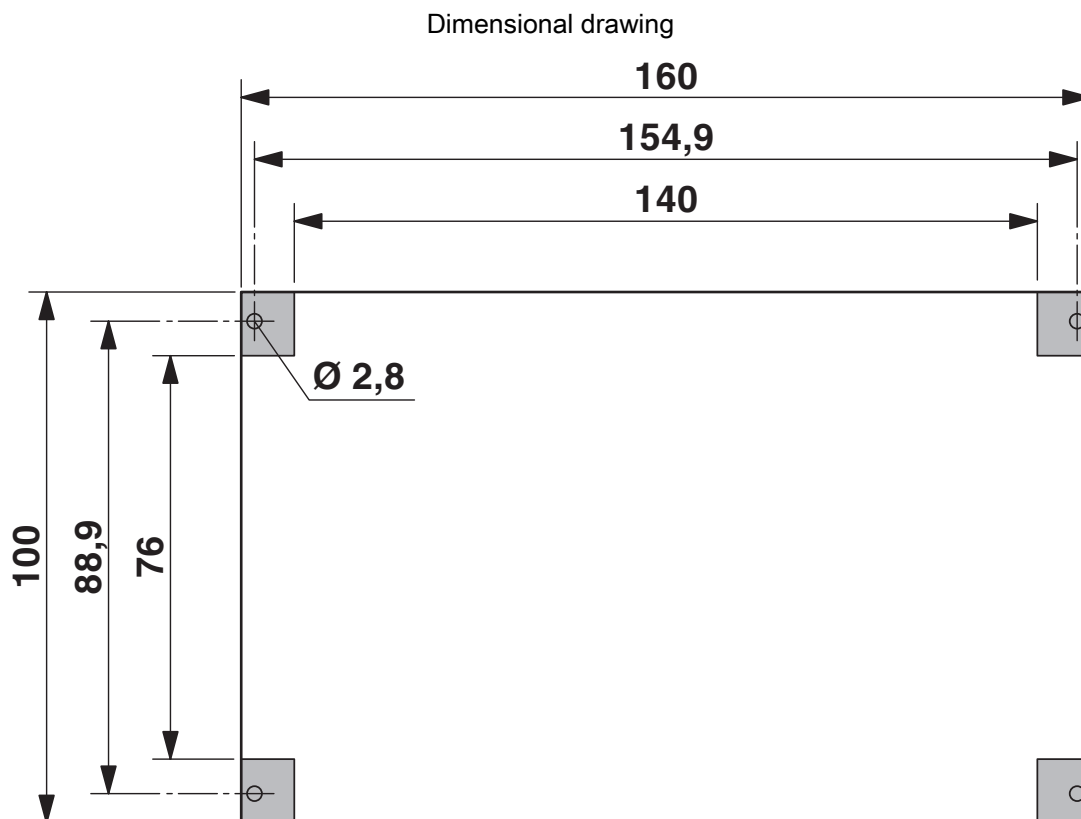

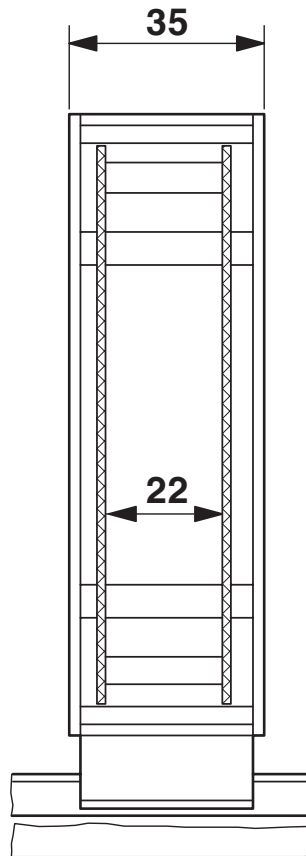

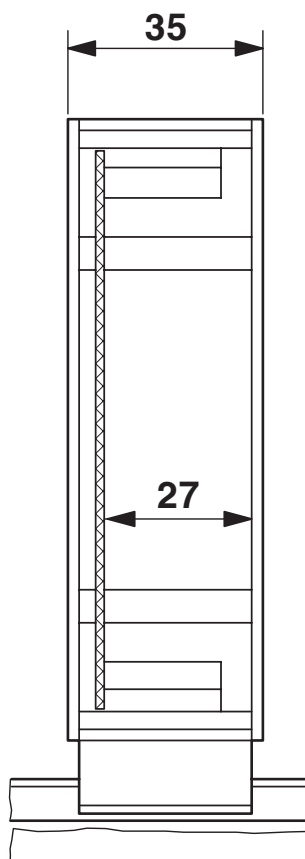

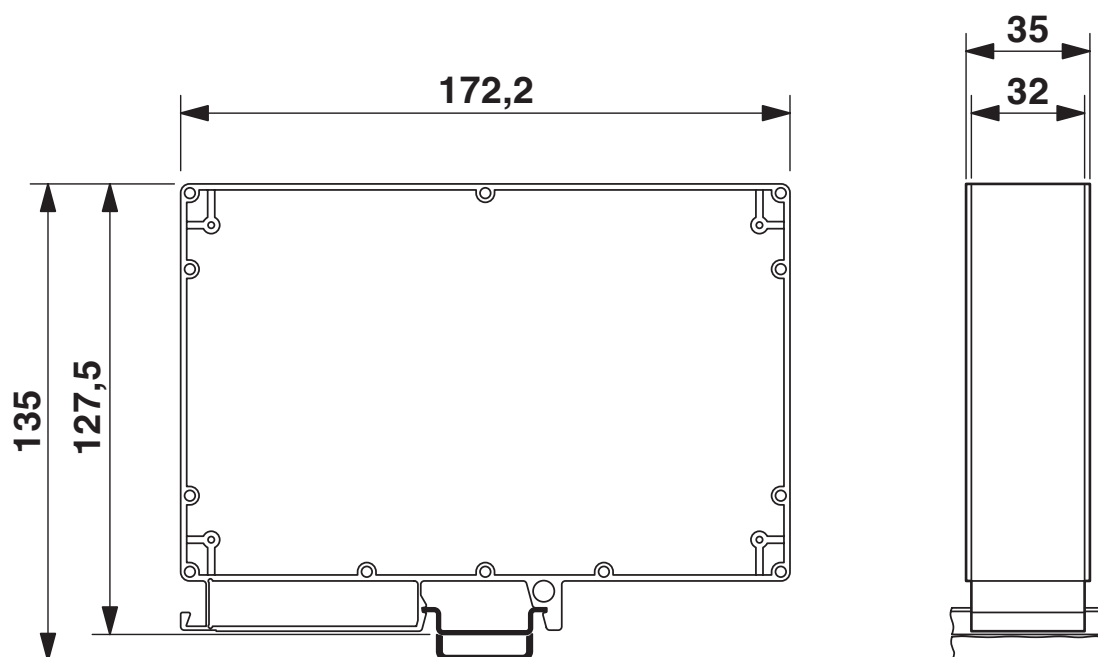
Maximum height of the components on the PCB with 2 PCBs

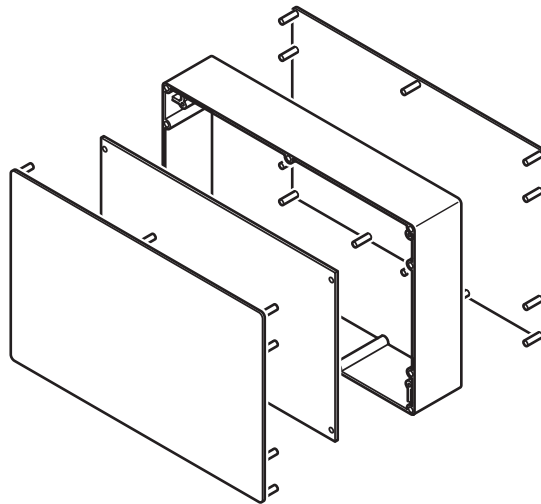

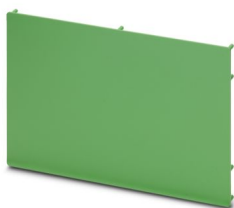
