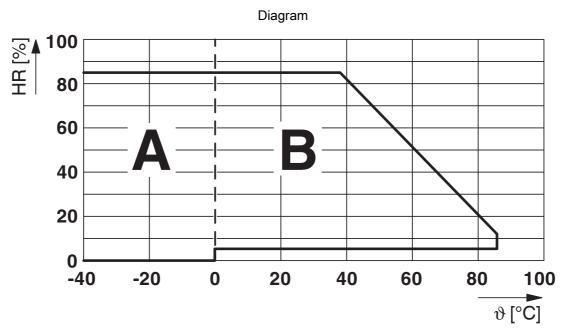

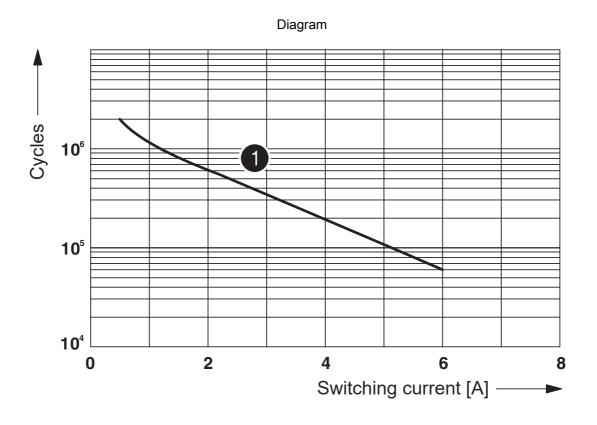

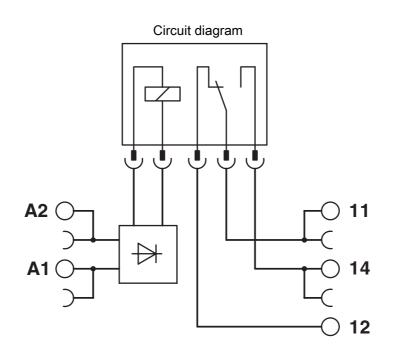

Electrical service life

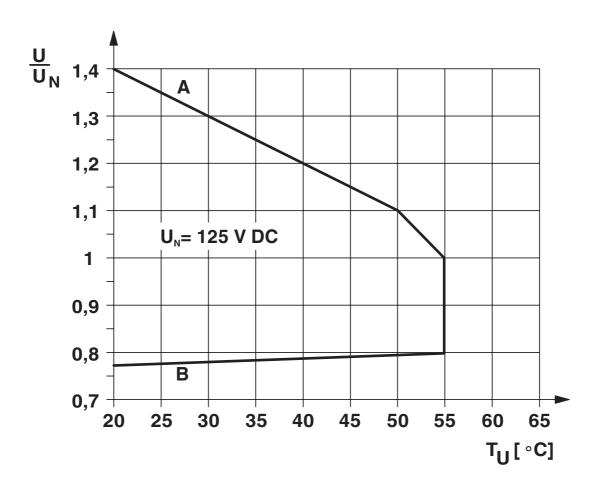
