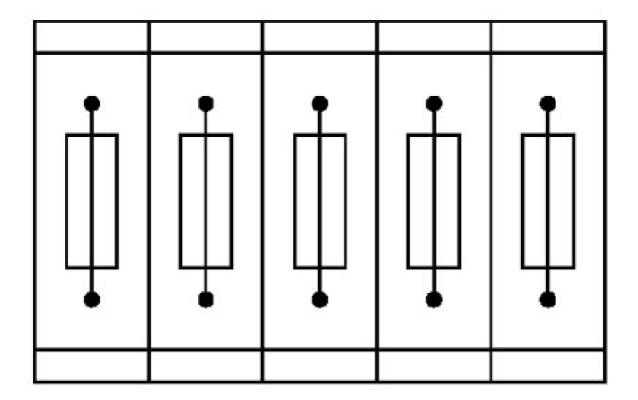

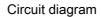


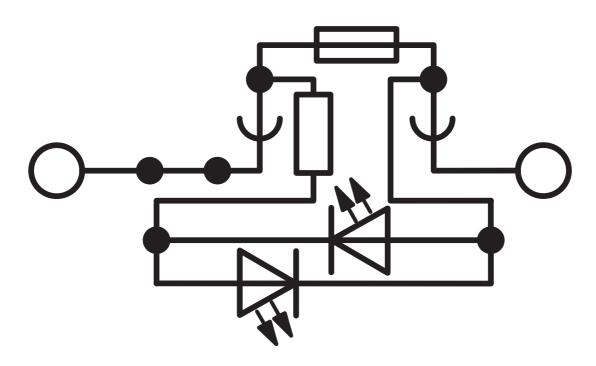
Fuse terminal blocks in interconnected arrangement, block consisting of 5 fuse terminal blocks

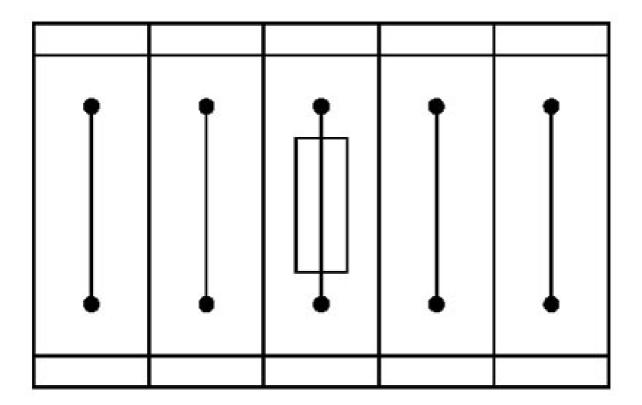

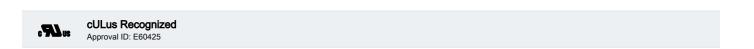
